Subject: Grant of Domestic Help Allowance and Medical Allowance in respect of Rajasthan Government Judicial pensioners/family pensioners with effect from 01-01-2016.

In continuation to this office circular No. Pen. Co-ordn./Rajasthan/Vol.-VI/Rev-Judi-DHA&MA/269 dated 19-03-2012, this is to state that the Government of Rajasthan in their their Law and Legal Affairs Deptt. Order No. F.26(55) Nyay/2015 part IV dated 12-03-2024 has enhanced the rate of Domestic Help Allowance to Rs.9000/- (Rupees Nine thousand) only per month with effect from 01-01-2016 in respect of retired Judicial Officers and Higher Judicial Officers of Rajasthan Judicial Service, from their existing rate of Rs.2500/- per month. Domestic Help Allowance @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month shall be admissible to the family pensioners of Judicial Service with effect from 01-01-2016 in terms of Order dated 12-03-2024 mentioned above.

- 2. For pensioners/family pensioners this allowance shall stand increased by 30% on completion of five years from 01-01-2016 that is, with effect from 01-01-2021, accordingly Domestic Help Allowance @ Rs.11700/- and Rs.9750/- per month with effect from 01-01-2021 is payable to the pensioners/family pensioners respectively.
- 3. Moreover, Government of Rajasthan in their aforesaid Order dated 12-03-2024 has enhanced the rate of Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month to such pensioners/family pensioners with effect from 01-01-2016, from their existing rate of Rs.1500/-.
- 4. The spouse or other dependents of Judicial Officers drawing family pension shall also be eligible for medical facilities/reimbursement at par with the pensioners of the judiciary.
- 5. Having been authorized by the Accountant General (A&E), Rajasthan in their authority No. Pension Auth./Order/K-107/2024-25/583 dated 28-05-2024, it is requested to make necessary arrangement for payment of Domestic Help Allowance and Medical Allowance with effect from 01-01-2016 keeping in view the instructions laid down above after proper adjustment.
