Subject: Grant of Domestic Help Allowance and Medical Allowance in respect of Uttar Pradesh Government Judicial pensioners/family pensioners with effect from 01-01-2016.

This is to state that the Government of Uttar Pradesh in their Order No. 140/II-4-2024-45(1)/2020 T.C.1 dated 28-02-2024 has sanctioned Domestic Help Allowance of @ Rs.9000/-(Rupees Nine thousand) only per month to their retired Judicial Officers and @ Rs.7500/-(Rupees Seven thousand and five hundred) only per month to the family pensioners of Judicial Service with effect from 01-01-2016.

- 2. For pensioners/family pensioners this allowance shall stand increased by 30% on completion of five years from 01-01-2016 that is, with effect from 01-01-2021.
- 3. The said Allowance shall be paid to such pensioners/family pensioners on the basis of their self-certification in this regard.
- 4. Moreover, Government of Uttar Pradesh in their aforesaid Order dated 28-02-2024 has sanctioned Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month to such pensioners/family pensioners with effect from 01-01-2016. The spouse or other dependents of Judicial Officers drawing family pension shall also be eligible for medical facilities/reimbursement at par with the pensioners of the judiciary.
- 5. Having been authorized by the Accountant General (A&E), Uttar Pradesh in their authority No. Pension Miscellaneous/DRY No.6973 dated 07-05-2024, it is requested to make necessary arrangement for payment of Domestic Help Allowance and Medical Allowance with effect from 01-01-2016 at the aforesaid rates keeping in view the instructions laid down above after proper adjustment.
- 6. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Uttar Pradesh etc."
