Subject : Grant of dearness relief to the Manipur Government pensioners/family pensioners with effect from 01-03-2024.

In continuation to this office circular No. Pen. Co-ordn./Manipur/Vol.-V/DR/110 dated 30-11-2021, this is to state that the Government of Manipur in their Memo No. 2/6/2010-FD(PIC)(Pt) dated 07-03-2024 has sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-03-2024	32% of basic pension/family pension

2. The above dearness relief will also be admissible on the additional basic pension/additional family pension available to older pensioners/family pensioners based on their age.

3. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of dearness relief in respect of employed family pensioners and re-employed Manipur Government pensioners will remain unchanged.

5. Having been authorized by the Principal Accountant General (A&E), Manipur in their letter No. Pen-1/MAN-MA/2024/104674 dated 14-05-2024, it is requested to make necessary arrangement for payment of dearness relief @ 32% on pension/family pension of Manipur Government pensioners/family pensioners with effect from 01-03-2024 as per instructions laid down above and after proper adjustment.

6. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Manipur etc."
