*Subject : Grant of dearness relief to the pensioners/family pensioners of Tripura
Government Judicial Services with effect from 01-01-2024.*

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VI/DR-Judi/169 dated 16-01-2024, this is to state that the Government of Tripura in their Memo No. F.5(6)-FIN(G)/79(Part-III)/32 dated 18-06-2024 has enhanced the dearness relief from the existing rate of 46% to 50% with effect from 01-01-2024 to the pensioners/family pensioners of their Judicial Services.

2. Having been authorised by the Pr. Accountant General (A&E), Tripura in their letter No. Pen-1/Tripura Relief/Judicial/2023-24/18623 dated 24-06-2024, it is requested to make necessary arrangement for payment of dearness relief @ 50% to all eligible pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-01-2024 after proper adjustment.

3. As per the aforesaid letter dated 24-06-2024, circular for further enhancement of dearness relief payable to retired Judicial Service Officers/family pensioners will be issued from time to time on receipt of necessary authorization from the o/o the Pr. Accountant General (A&E), Tripura.

4. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Tripura etc."
