Subject: Revision of pension/family pension with effect from 01-01-2016 in respect of pre-01-01-2016 Judicial Officers of Andhra Pradesh State Judicial Services.

This is to state that the Government of Andhra Pradesh in their LAW (LA&J. SC.F) Deptt. G.O.Ms.No. 89 dated 01-11-2023 has revised pension/family pension in respect of the Judicial Officers of Andhra Pradesh State Judicial Services who have retired or died while in service prior to 01-01-2016 as recommended by Second National Judicial Pay Commission as under:

- i) The pension of retired Judicial Officers who retired prior to 01-01-2016 would be 50% of the last drawn pay of the post held at the time of retirement.
- ii) The revision of pension shall be (a) multiplier factor of 2.81 applicable for pension; or (b) pensioners fitted at appropriate level in the fitment table II (copy enclosed) whichever is higher.
- iii) Judicial Officers who retired prior to 01-01-2016 to be placed notionally at the corresponding stage.
- iv) For Judicial Officers who retired prior to 01-01-1996, if no consequential re-fixation has been done, the said benefit shall be extended to them first without further delay.
- v) The benefits of number of years of practice at bar subject to maximum of weightage of ten years will be given to direct recruits of HJS who retired prior to 01-01-2016.
- vi) Family pension @ 30% will be paid to the eligible family member as given in Rule 54 of Central Civil Services (Pension) Rules 1972 at par with the spouse, after the death of the spouse.
- vii) The quantum of family pension shall be worked out in the same manner as quantum of pension is worked out.
- 2. The additional quantum of pension/family pension shall be admissible to the Judicial Officers with effect from 01-01-2016 on completion of age of and at the revised rates specified as under

Age of pensioner/family pensioner	Additional quantum of pension/family pension
From 75 years to less than 80 years	20% of revised basic pension/family pension
From 80 years to less than 85 years	30% of revised basic pension/family pension
From 85 years to less than 90 years	40% of revised basic pension/family pension
From 90 years to less than 95 years	60% of revised basic pension/family pension
From 95 years to less than 100 years	80% of revised basic pension/family pension
100 years and above	100% of revised basic pension/family pension

3. Dearness relief shall be admissible at the rates applicable to the Central Government employees drawing VII Central Pay Commission Pay Scales. Accordingly, as per GO dated 22-10-2022 ibid, G.O.Ms.Nos. 115 dated 22-10-2023, 126 dated 01-12-2023 and 26 dated 14-03-2024 dearness relief shall be paid to such pensioners/family pensioners at the rate and from the date mentioned below:

Date of effect	Rate of dearness relief per month
01-01-2016	NIL
01-07-2016	2% of basic pension/family pension
01-01-2017	4% of basic pension/family pension
01-07-2017	5% of basic pension/family pension
01-01-2018	7% of basic pension/family pension
01-07-2018	9% of basic pension/family pension
01-01-2019	12% of basic pension/family pension
01-07-2019	17% of basic pension/family pension
01-07-2021	31% of basic pension/family pension
01-01-2022	34% of basic pension/family pension
01-07-2022	38% of basic pension/family pension
01-01-2023	42% of basic pension/family pension
01-07-2023	46% of basic pension/family pension

- 4. As regards the other allowances, such as Domestic Help Allowance/Medical Allowance etc., the amounts presently being drawn shall continue to be drawn, until issuance of further circular in the matter from this end on receipt of necessary authorization from the o/o the Principal Accountant General (A&E), Andhra Pradesh.
- 5. On death of pensioner/family pensioner, arrear of revised pension/family pension to be paid to nominee(s) of lifetime arrear of pension and in absence of any valid nomination to his/her legal heir(s).
- 6. The revised rates of pension, which have been approved by the Supreme Court, shall be payable from 01-07-2023. Arrears of pensions, additional pensions and other retiral benefits as well, will be paid in full.
- 7. Having been authorized by the Principal Accountant General (A&E), Andhra Pradesh in their letter Nos. PAG (A&E)/AP/OGP/2023-24/339181 (SSA No. 16595) dated 20-12-2023, PAG (A&E)/AP/OGP/2023-24/339635 (SSA No. 16637) dated 08-01-2024, PAG (A&E)/AP/OGP/2024-25/342614 (SSA No. 16691) dated 08-04-2024 and PAG (A&E)/AP/OGP/2024-25/343739 dated 20-05-2024, it is requested to make necessary arrangement for payment of revised pension/family pension to all eligible pensioners/family pensioners of Andhra Pradesh State Judicial Services with effect from 01-07-2023 along with arrears with effect from 01-01-2016 to 30-06-2023 keeping in view the instructions laid down above, after proper adjustment.
- 8. This order shall not be applicable for post-01-01-2016 pensioners/family pensioners of Andhra Pradesh State Judicial Services. In their cases, individual authorities will be issued on receipt of the same from the o/o the Principal Accountant General (A&E), Andhra Pradesh.
- 9. The charges on this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Andhra Pradesh etc."
