Co-ordn./Kerala/Vol.VIII/Rev-Judi/ 150 dated 20-12-2023, this is to state that the Government of Kerala in their GO (P) Nos. 15/2024/FIN dated 11-03-2024, 19/2024/FIN dated 14-03-2024 and 36/2024/FIN dated 08-05-2024 has revised the rate of dearness relief payable to their Judicial pensioners/family pensioners with effect from 01-01-2023, 01-07-2023 and 01-01-2024 as under:

| Date of effect | Rate of dearness relief per month |
|----------------|-----------------------------------|
| 01-01-2023 | 42% of pension/family pension |
| 01-07-2023 | 46% of pension/family pension |
| 01-01-2024 | 50% of pension/family pension |

- 2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.
- 3. Having been authorized by the office of the Accountant General (A&E), Kerala in their authority No. P19/IV/DRSSA/2023-24/Kerala/53462/215 dated 03-06-2024, it is requested to make necessary arrangement for payment of dearness relief @ 42%, 46% and 50% to all eligible Kerala Government Judicial pensioners/family pensioners with effect from 01-01-2023, 01-07-2023 and 01-01-2024 respectively along with arrears after proper adjustment.
