In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR-un-rev/183 dated 30-01-2024, this is to state that the Government of Goa in their Order No. 3/2/92-Fin(Exp)/Part File-IV/59 dated 19-06-2024 has sanctioned dearness relief to the pensioners/family pensioners of Goa Government and its Autonomous Bodies/Corporation including Ex-gratia pensioners drawing pensions under C/B/D & E series, Pensao de Sangue pensioners, pensioners receiving pension under triple benefit scheme, recipients of Exgratia i.e. families of deceased pensioners who were governed under EFU, pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under series T and E.B., who are in receipt of pension/family pension in pre-revised pay structure/scales of Sixth Central Pay Commission, at the rate and from the date as under:

- 3) Having been authorized by the Directorate of Accounts, Government of Goa in their letter No. DA/PA-I/Pens (5)/2024-25/DR-753/TR-316 dated 09-07-2024, it is requested to make necessary arrangement for payment of dearness relief to all eligible above category of Goa Government pensioners/family pensioners mentioned above directly @ 239% on their basic pension/family pension with effect from 01-01-2024 after proper adjustment.
