Subject : Grant of Dearness Relief to the Jammu & Kashmir Government pensioners/family pensioners with effect from 01-01-2024.

In continuation to this office circular No. Pen. Co-ordn./Jammu & Kashmir/Vol.- III/DR/12 dated 16-04-2024, this is to state that Government of Jammu & Kashmir in their Order No. 179-F of 2024 dated 21-05-2024 has sanctioned dearness relief to JK UT pensioners/family pensioners as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-01-2024	50% of basic pension/family pension

2. Payment of dearness relief involving a fraction of 50 paise and above shall be rounded to the next rupee and the fractions of less than 50 paise shall be ignored.

3. Personal pension, if any, will not be taken into account for determining dearness relief on pension.

4. The other provisions governing grant of dearness relief on pension/family pension such as regulation of Dearness Allowance during employment/re-employment, where more than one pension is drawn etc. and other provisions of the existing orders/rules (as are not in conflict of the provisions of this order) shall continue to remain in force.

5. Having been authorised by the Principal Accountant General (A&E) Jammu & Kashmir in their authority No. Pen.A/c/2024-25/DA/192-224 dated 06-06-2024, it is requested to make necessary arrangement for payment of dearness relief @ 50% on basic pension/family pension with effect from 01-01-2024 to all eligible Jammu & Kashmir UT pensioners/family pensioners keeping in view the instructions laid down above and after making proper adjustment.
