**Subject: Revision of monetary ceiling for reimbursement of Briefcase/Office Bag/Ladies Purse for official use in IA&AD**


Sir/Madam,

The competent authority has revised the monetary ceiling limit for reimbursement of briefcase/office bag/ladies purse for official use to the entitled officials/officers of IA&AD holding regular post as under:

Pay Level	Ceiling (Rs.) [incl. of GST]
DAI(Level-17)	12500
ADAI/DG/PAG(Level 15-16)	10000
PD/AG(Level-14)	8125
Director/Sr. DAG/Sr. PPS/PSO(Level 12-13)	6250
Dy. Director/DAG/PPS(Level-11)	5000
Level 8 to Level 10	5000/-
Level 6 to Level 7	4375/-

- The entitled officers/officials can purchase briefcase/office bag/ladies purse of their own choice from any private/public outlet. However, reimbursement shall be restricted to the above mentioned ceiling limits.
- The reimbursement of briefcase/office bag/ladies purse shall be made to the above officials/officers on joining this Department or on completion of three years from the date of issue of earlier one.
- These orders will be in force from 01.01.2024, however, old settled cases may not be reopened.
