Subject: Age proof for grant of additional family pension to the Uttar Pradesh Government family pensioners on the age of 80 years and above.

Date: 12-09-2024

This is to state that the Government of Uttar Pradesh in their Memo No. Sa.3-1515/X-2008-308-97 dated 08-12-2008, followed by Corrigendum issued vide Government of Uttar Pradesh Order No. Sa-3-G.I.-28/X-2008 dated 06-01-2009, circulated under this office No. Pen. Co-ordn./U.P./Vol.-VI/Revision/22 dated 14-05-2009, had sanctioned additional pension/family pension to the old Uttar Pradesh Government pensioners/family pensioners aged 80 years and above which has been continued vide their Order No. 39/2016-Sa-3-923/X-2016-308/2016 dated 23-12-2016, circulated under No. Pen. Co-ordn./UP/Vol.-VII/Revision/58 dated 04-07-2017.

- 2. Government of Uttar Pradesh in their Order No. Sa-3-1541/X-2008-308/97T.C. dated 17-01-2009 has decided that the process of payment additional pension to pensioners/family pensioners above 80 years of age and above will be done at the bank/treasury level and like pensioners, family pensioners will be given additional family pension facility on attaining the age of 80 years or more. All pensioners/family pensioners will have been intimated to the Head of Department/Head of the Office will verify this from the records maintained in the office.
- 3. If any details related to the age of family pension are available in the office records like nomination form or pension form filled for General Provident Fund or any other purpose, then only the same will be recognized and will be made available to the treasury accordingly. If only age is mentioned (in case date of birth is not mentioned), 01 July of that year will be considered as date of birth. If age is not mentioned in the above mentioned records, high school certificate of the family pensioner and if high school certificate is not available, then the date of birth mentioned in the driving license/PAN card/election identity card, if any, will have been considered. If any family pensioner does not have any of the above mentioned means of proof, then in such a situation, separate proof of the said intension of the pensioner/family pensioner should be given and the age certificate given by the CMO for the date of birth of such pensioner/family pensioner will be valid.
- 4. Having been authorised by the Principal Accountant General (A&E)-II, Uttar Pradesh in their authority No. S.S.A.-2/CD-140/1590 dated 28-05-2024, it is requested to make necessary arrangement to act upon accordingly for payment of additional pension/family pension to the old Uttar Pradesh Government pensioners/family pensioners aged 80 years and above, in case the date of birth is not mentioned in the PPO/FPPO.
