Senior Audit Officers willing to be considered for deputation to Central/State Government offices/Autonomous bodies/Public sector undertakings in Tamil Nadu and other States for Panel Year 2024-25 may give their willingness in the prescribed proforma, through proper channel on or before 15.09.2024 to Administration II section. The list will normally be valid for one year. The Officials working in the Office of the PAG (Audit-II), TN & Puducherry and office of the DGA (Central) should submit the filled in proforma to their respective Offices and the same is to be forwarded with the recommendations of the Principal Accountant General/ Director General of Audit (Central), Chennai.

On the closing date of receipt of applications the applicants should not have crossed the age of 56 years and should have served at least for a period of 05 years in the cadre. It is to be noted that an Officer who declines to proceed on deputation after selection will be barred from further deputation for a period of one year.

Officers repatriated from deputation outside IA&AD will not be considered for any other deputation before he/she completes three years of cooling-off period. It should also be noted that the period of deputation will not, normally exceed four years in or outside IA&AD.
