ORDER

In terms of para 7 of Headquarters' circular No. 27-Staff(App-III)/2024 dated 16th August 2024, the Divisional Accountants on probation are to be assigned to a Division under the supervision of a senior official (DAO-II/DAO-I/Sr. DAO) posted in the same/nearby Station.

Accordingly, the Supervisory Charges of the following divisions where Divisional Accountants (Probationer) have been posted, are entrusted to the officials (DAO-II/DAO-I/Sr. DAO) mentioned in 'Annexure-I' on interim basis with immediate effect.

In view of the above, following instructions are hereby issued to the officers holding Supervisory charge and the DAs (Probationer):

1. The officials holding supervisory charge will be authorized to sign the accounts of the division. The Supervising officers will be held responsible for the lapse, if any.
2. DA (Probationer) is not authorized to sign the accounts of the division until completion of the probation period and confirmation in the service.
3. The DA (Probationer) will be held responsible for preparation of accounts and other reports of the division and the same will be examined and signed by the Supervising Officer and the Executive Engineer of the division. The accounts and other relevant documents of the division are to be forwarded to the office of the Accountant General (A&E), West Bengal by due date and the same may be ensured by the DA (Probationer) as well as by the Supervising Officer.
4. Adverse comments, if any, by Supervising Officer/Executive Engineer of the division on performance of the DA (Probationer) may impact on his/her completion of probation period and transfer/posting of the concerned DA (Probationer).
