Subject: Grant of Domestic Help Allowance and Medical Allowance to the pensioners/family pensioners of Uttarakhand

Judicial Service with effect from 01-01-2016.

This is to state that the Government of Uttarakhand in their Law Department Order No. 88/XXXVI-A-1/2024-261/2022 (E-68460) dated 23-02-2024 has sanctioned Domestic Help Allowance and Medical Allowance in respect of pensioners/family pensioners of the Uttarakhand Judicial Service with effect from 01-01-2016 as under:

- a) Domestic Help Allowance to such pensioners and family pensioners @ Rs.9000/-(Rupees Nine thousand) and @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month respectively shall be admissible with effect from 01-01-2016. This allowance shall stand increased by 30% on completion of five years from 01-01-2016 that is, with effect from 01-01-2021.
- b) Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month shall also be admissible to such pensioners/family pensioners with effect from 01-01-2016.
- 2. Having been authorized by the Accountant General (A&E), Uttarakhand in their authority No. P.A./Pension/Uttarakhand Order/S.N.Judicial/D.R.-52/2024-25/738 dated 18-07-2024, it is requested to make necessary arrangement for payment of revised rate of Domestic Help Allowance @ Rs.9000/- (Rupees Nine thousand) and @ Rs.7500/- (Rupees Seven thousand and five hundred) only per month to the pensioners and family pensioners respectively and Medical Allowance @ Rs.4000/- (Rupees Four thousand) only per month to the pensioners/family pensioners of Uttarakhand Judicial Service with effect from 01-01-2016 keeping in view the instructions laid down above, after proper adjustment.
