Subject to eligibility, their pay in Level-10 of 7th CPC Pay Matrix will be fixed under Rule 13 of CCS (Revised Pay) Rules, 2016 notified vide Gazette Notification GSR 721 (E) F. No. 1-2/2016-1C dated 25.07.2016. He may exercise the option for fixation of pay on promotion within one month from the date of promotion.

As per Recruitment Rule for the post of Sr. DAO in Part-II, Section 3, Sub-Section (1) of Gazette of India vide GSR No. 10 dated 17.01.2020 published in Gazette of India on 25.01.2020, on their promotion, Sr. DAO will be on probation for a period of 2 (two) years followed by confirmation.

It is issued subject to further orders which may be passed by the Hon'ble Supreme Court as stipulated in para 5 of DoPT OM No. 36012/11/2016-Estt. (Res-I)(Pt-II) date 15.06.2018.
