#### **OFFICE ORDER**

Subject: Pre-registration of SAS/I/CPD Examinations in Examination-1 of 2024-reg.

Headquarters' office, vide letter no. 418 & 419/14-Exam/SAS etc. Exam/2024 dt. - 13/11/2024, has intimated that the SAS/I/CPD-I, II & III Examination-1 of 2024 would be held from 17<sup>th</sup> December to 23<sup>rd</sup> December 2024. The date sheet of examination will be intimated in due course. The registration process for the SAS/I/CPD-I, II & III Examinations in Examination-1 of 2024 will commence from 20<sup>th</sup> November 2024 and will end on 30<sup>th</sup> November 2024. The cut-off date for eligibility for the examination is 1<sup>st</sup> September 2024. Applications are therefore invited for pre-registration of candidature for Examination-1 of 2024 (SAS/I/CPD) from officials fulfilling the eligibility criteria as mentioned below.

#### 1. SAS Examination: -

- Officials who were declared to have passed the Preliminary Test for SAS Examination-1 of 2024 and belong to the ST category only.
- <u>iii</u> Divisional Accountant or Divisional Accounts Officer-II, who have successfully completed their probation period on or before 1<sup>st</sup> September 2024 and belong to the ST category only.
- iii) All existing candidates are allowed to appear in SAS Exam-1 of 2024.
- iv) All DRAAOs are allowed to appear in SAS Exam-1 of 2024.
- In light of Headquarters' Circular No. 11 of 2020 dt. 19.10.20, the total chances of passing the SAS Examination have been increased from ten to twelve (6 normal + 6 additional). The additional six chances will be admissible only to those candidates who have cleared five papers within the first (normal) 06 chances. Six additional chances will not be consecutive as earlier but the time limit for passing the SAS Examination will be eight years considering two examinations in a year (8 years for 12 chances) i.e. SAS Examination-1 of 2021.
- vi) No new departmental candidate is allowed where vacancy is not available.
- vii) Revised syllabus of SAS exam will be implemented from SAS Exam-2 of 2025.

### 2. Incentive Examination\*: -

- i). Sr. Accounts Officer (Sr. AO)/Sr. Divisional Accounts Officer (Sr. DAO) are eligible to appear in the Incentive Examination.
- ii). Divisional Accounts Officer Gr. I/Assistant Accounts Officer (AAO) who have completed oneyear continuous service in the grade/cadre as on 1<sup>st</sup> September'2024.

#### 3. CPD I/ II & III Examination\*:-

- i). Sr. AO/Sr. DAO are eligible to take the first CPD test. AAO/DAO Gr I who have completed four years of continuous service in the grade/cadre as on 1<sup>st</sup> September'2024 are eligible to appear in CPD-I Examination.
- ii). Sr AO/Sr. DAO/AAO/DAO Gr I after elapse of four years from qualifying their first CPD test are eligible to appear in CPD-II Examination.
- iii). The third and final CPD test can be taken by the Sr. AO/Sr. DAO/AAO/DAO Gr.I after elapse of three years from qualifying their second CPD test.

In view of the above, a single pre-registration form may be submitted by the officials clearly indicating the Exam(s) in which she/he intends to appear. Officials are required to submit duly completed Pre-registration form in the enclosed format to Trg & Exam section or through email at agaebihar@cag.gov.in by 27.11.2024.
