As per DoPT Office Memorandum No. F.No.11013/6/2018-Estt.A-III dated 07.02.2019, Government Servants have to intimate to the Government (in the prescribed proforma) where the cumulative transactions in shares, securities, mutual funds scheme etc., exceed six months' basic pay of government servant during the calendar year.

Therefore, all the officials of this office are hereby directed to intimate transactions in shares, securities, mutual funds schemes as required under the above said OM for the calendar year 2024 i.e., from 01.01.2024 to 31.12.2024 in Admn. III section on or before 31.01.2025. Proforma is available at (1) intranet (within the office): http://10.53.194.22; and (2) internet: 117.247.178.78

Further, it is reiterated that since shares, securities, debentures etc., are treated as movable property, Government has to be intimated, if an individual transaction exceeds twice the basic pay of a government servant, under Rule 18(3) of CCS(Conduct) Rules, 1964.
