Having been authorized by the Principal Accountant General (A&E), Tripura in their authority No. Pen-1/Tripura Relief/2023-24/19893-19932 dated 08-11-2024, it is requested to make necessary arrangement for payment of dearness relief to all eligible Tripura Government pensioners/family pensioners @ 30% on their revised basic pension/family pension with effect from 01-11-2024 after proper adjustment.
