- (ii) Grant of Dearness Relief to the Chhattisgarh Government pensioners/family pensioners on their pre-revised pension/family pension with effect from 01-10-2024.

In continuation to this office circular No. Pen. Co-ordn./Chhattisgarh/Vol.-II/DR-rev&un-rev/18 dated 29-04-2024, this is to state that the Government of Chhattisgarh in their Order No. 835/F-2013-04-00416/Fin./Rule/IV dated 30-10-2024 has sanctioned dearness relief to their pensioners/family pensioners including additional pension holders whose pension/family pension has been revised in terms of Government of Chhattisgarh Order No. 296/F 2017-41-03685/Fin/Rule/IV dated 06-07-2018 (this office circular No. Pen. Co-ordn./Chhattisgarh/Vol.-II/Revision/150 dated 08-11-2018), as under:

Rate of dearness relief per month

01-10-2024

50% of basic pension/family pension

2. Besides, in continuation to this office circular 29-04-2024 mentioned above, this is to state that the Government of Chhattisgarh in their aforesaid Order dated 30-10-2024 has sanctioned dearness relief to their pensioners/family pensioners including additional pension holders (payable to old pensioners) whose pension/family pension has been revised in terms of Government of Chhattisgarh Order Nos. 262/236/R/IV/2009 or 264/236/R/IV/2009 both dated 31-08-2009 (this office circular No. Pen. Co-ordn./Chhattisgarh/Revision/131 dated 07-12-2009), as under:

Rate of dearness relief per month
01-10-2024
239% of basic pension/family pension

3. The above mentioned dearness relief shall be payable to the persons receiving pension, family pension and extra ordinary pension under the restrictions contained in the Chhattisgarh Government FD Memo No. 677/279/2024/Fin./Rule/IV dated 23-09-2024 (Finance

Circular 07/2024) and F.B. 6/43/76/R-II/IV dated 05-10-1976.

- 4. Pensioners who have commuted a part of their pension shall be paid dearness relief on their original pension (pension before commutation).
- 5. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next rupee.
- 6. Having been authorized by the Accountant General (A&E), Chhattisgarh in their letter No. P.A./Chhattisgarh Relief Order/S.S.A.Letter/1005 dated 04-12-2024, it is requested to make necessary arrangement for payment of dearness relief @ 50% to all eligible Chhattisgarh Government pensioners/family pensioners on their revised basic pension/family pension including additional pension/family pension with effect from 01-10-2024 whose pension/family pension has been revised as per this office circular dated 08-11-2018 ibid after proper adjustment. It is also requested to make necessary arrangement for payment of dearness relief @ 239% with effect from 01-10-2024 to all eligible Chhattisgarh Government pensioners/family pensioners on their basic pension/family pension including additional pension/family pension, whose pension/family pension has been revised as per this office circular dated 07-12-2009 but not as per circular dated 08-11-2018 ibid, after adjustment of the amount already paid.
