OFFICE ORDER

Shri Dinesh Kumar Redhu, Accountant on deputation to O/o the Director of Accounts, Cabinet Secretariat, New Delhi was empanelled for promotion to the post of Senior Accountant during the panel year 2025. He has declined to accept promotion to the cadre of Senior Accountant.

Principal Accountant General has accepted the request of Shri Dinesh Kumar Redhu, Accountant to refuse the promotion to the cadre of Senior Accountant.

Shri Dinesh Kumar Redhu, Accountant will not be eligible to be considered for further financial up-gradation under the MACPS in terms of para 25 of Annexure to DoPT O.M. dated 19-05-2009 regarding MACPS due to his refusal for promotion to the cadre of Senior Accountant.

Shri Dinesh Kumar Redhu, Accountant is debarred for promotion for one year from the date of taking over charge of his junior i.e. 03-02-2025 to 02-02-2026 or till a next vacancy arises, whichever is later. On his eventual promotion to the higher grade, he will lose seniority vis-à-vis his juniors promoted to the higher grade earlier irrespective of the fact whether the posts in question are filled by selection or otherwise.
