Madam/Sir,

The UN Audit Examination 2025, an examination for shortlisting of Sr. AOs/AAOs for UN Audit to be taken up during 2025-26 and 2026-27, would be held at the end of March 2025. Officers from all streams i.e. Audit/Accounts etc who satisfy the eligibility criteria given in **Annexure-1**, are eligible to apply. HoDs are requested to collect willingness and other details from the candidates well before the registration process for the exam.

- 2. While no restriction is placed on the number of applications to be received from an office, it may please be ensured that names of only eligible officers are recommended. The registration process will be started in due course. Offices may collect the information listed in **Annexure-2**, from the eligible and willing officers, which will be required during the registration process.
- 3. The examination will be held in Computer Based Test (CBT) mode at seven cities *viz*. Delhi, Mumbai, Chennai, Kolkata, Guwahati, Bangalore and Hyderabad, depending on the number of candidates. Officers currently working in different States/UTs shall be required to opt for the examination centre as per the list given in **Annexure-3**. Exact venue for the examination will be intimated in due course.
- 4. The photocopy of the APARs is not required to be sent at this stage. However, your recommendations, along with the abstracts of APARS for the last available five years up to 2023-24, vigilance/disciplinary clearance certificate and penalty/administrative action such as suspension, diesnon and criminal charges clearance certificate in the prescribed proforma (Annexure-4) duly certified by the St. DAG/Director/DAG/DD (Admn)/Director (P)/DG (Commercial) may be uploaded at the time of registration of the candidate.
- 5. There will be **no scope for submission of applications/documents offline** and, therefore, complete application along with all the required documents and your recommendation must be **submitted online only** when the registration window opens. If at any stage, the information furnished by any candidate(s) is found to be inaccurate, his/her candidature/selection is liable to be cancelled/terminated without any notice and action taken as per rules.
- 6. Officers who withdraw their candidature after being selected for UN Audit (except on severe medical grounds like surgery of self or direct family members) will be banned for a specific period from appearing/applying for international assignments/international postings/international training.



- 7. The syllabus of UN Audit Exam is available at www.cag.gov.in under the Examination tab (cag.gov.in>Departmental Examinations>Syllabus and Books> Syllabus of UN Audit examination).
- 8. A list of recommended candidates and all required documents may be kept ready so that the registration process can be completed on short notice/period.
