**Revised Result**

The result of Divisional Accountants Grade Examination (DAGE) held in the month of October 2024 was declared on 16.01.2025 and a total of 15 candidates were declared passed in the said examination. After declaration of the result, a representation was received by this Office regarding providing relaxation in passing marks in case of a candidate with Benchmark Disability. This Office took a review of the result and found that a relaxation of 5% of marks was to be provided for two of the candidates belonging to eligible categories. Based on the said review, the discrepancy has been rectified, and the following changes have been effected in the result initially declared on 16.01.2025:

1. Candidate having index number 29, who was earlier marked 'not exempted' in Paper-II and Paper-IV, has now marked exempted in these two Papers.
2. Candidate having index number 33, who was earlier marked 'not exempted' in Paper-V, has now marked exempted in this Paper.

Accordingly, to incorporate the changes indicated above, the result declared by this Office earlier on 16.01.2025 stands revised. The revised result/statement of marks incorporating the limited changes indicated above are given at Annexure-I.
