Every competency will have assessments attached to it and only after passing the assessment with minimum required score, the official will be able to acquire the competency and attach it to his/her competency list.

Accordingly, DoPT has enabled that all government employees, with nic.in or @gov.in or @cag.gov.in email lds. can register and onboard themselves on iGOT Karmayogi platform directly through the URL https://igotkarmayogi.gov.in.

HODs are requested to monitor the enrolment and completion of the courses through the existing reporting mechanism for capacity building.
