3. In this regard, all the field offices are requested to adhere to the following instructions while nominating the candidates for the pre-examination training for CPD examinations:

- The pre-examination training for CPD examination will be conducted online **only**.
- Participation in the training is **voluntary**.
- The training will be conducted **only once** in a year for both the examinations i.e. Examination I & II of the respective year.
- The training is to be provided **only once** for each stage of CPD examination i.e. once for CPD I examination, once for CPD II Examination and once for CPD III Examination in the career of an officer.
- Officers who participated in the any of the online pre-examination CPD training conducted in 2022 ,2023 and 2024 are **ineligible** for nomination henceforth..

- Consideration for the training is restricted to SAOs, SrDAOs, AAOs, and DAOs Gr I who meet eligibility criteria as of **September 1, 2025**, for Examination 2 of 2025.
4. Keeping in view the points mentioned at para 3, all Heads of field offices/NAAA/iCISA/RCBKI/C are requested to ensure the following under intimation to K&CB Wing/Headquarters (kcbwing@cag.gov.in).
- Compile the list of eligible and willing SAOs/SrDAOs/AAOs/DAOs Gr I for pre-examination CPD training for the year 2025. All offices are requested to send the list of eligible candidates for each paper of CPD Examination who have not attended the training so far, to the respective training institutes latest by **31st March 2025**.
 - The designated training institutes may arrange online training through the SAI Capacity Building Portal.
 - Once the course is uploaded onto the SAI CB Portal, respective institutes will seek/solicit nominations from field offices through the portal.
5. The online trainings should be completed by **10th May 2025**.
