NOTICE

It is proposed to fill up vacancies in the cadre of Assistant Audit Officer by engagement of retired personnel on short term contract basis vide HQ circular no. 30, letter no. 1346-Staff (App.)-1/22-2016 dated 26.09.2023. Applications are invited from retired SAO/AO/AAO, who may be interested in taking up short term contract as a consultant in the post of Assistant Audit Officer (Rlys).

The terms and conditions for short term contract are as under:-

1. The retired personnel shall be appointed on a short term contract basis initially for a period of one year. Based on his/her performance and requirement of his/her services the contract may be further extended upto a maximum of five years or till he/she attains the age of 65 years whichever is earlier.
2. (a) The retired officers shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of the retirement. The amount so fixed shall remain unchanged for the term of the contract.
(b) An appropriate and fixed amount as transport allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
(c) No annual increment/percentage increase, Dearness Allowance and House Rent Allowance shall be allowed during the contract.
3. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed. However, absence during curfew, bandh, strike, lockdown will be dealt with in a similar way as in the case of serving officers/officials.
4. On engagement he/she is liable to be posted in the office of the Principal Director of Audit, N. F. Railway, Maligaon.
5. It may be noted that the appointment will be purely on temporary basis subject to termination at any time.
6. Last date for submission of application is **15.04.2025**.
