VACANCIES IN THE CADRE OF AAO's

Applications are invited from Retired Senior Accounts-Audit Officers / Assistant Accounts - Audit Officers to work on short term contract basis in the Office of the Accountant General (A&E), Karnataka, Bengaluru in accordance with the terms and conditions prescribed by Headquarters Office Circular No.27/2021 issued under No. 967 – Staff (App. I) /22-2016 dated 03.08.2021 against the vacancies in the Assistant Accounts Officer's cadre.

The following broad terms and conditions will be applicable to the contractual officials:

- a. Age should not be beyond 65 years.
- b. The Retired personnel would be initially hired for a period of one year and would be liable to be terminated at any time without prior notice, based on the administrative exigencies and the instructions received from the Headquarters office in this regard from time to time. The tenure is only for a period of one year subject to performance and requirement of services and maximum age limit of 65 years as per date of birth.
- c. Remuneration and allowances payable will be governed by OM No. 3 -25 /2020- E.III A dated 09.12.2020, issued by the Department of Expenditure, Ministry of Finance, Government of India, New Delhi, which is as under.
 - i. A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of contract.
 - ii. An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.

- iii. No annual increment/ percentage increase, Dearness Allowance and House rent allowance shall be allowed during the contract.
- iv. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retired Officers hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed. However, absence during curfew, bandh, strike, lockdown should be dealt with in a similar way as in the case of serving Officers as these are events beyond the control of any individual.
- v. If retired the Officers hired on short term contract basis remain absent, beyond paid leave in a month for reasons other than those indicated above, his/ her remuneration shall be deducted on pro-rata basis as under:

- vi. The appointment will be purely on temporary basis and is subject to termination at any time.
- vii. The retired Officers selected to be hired on short term contract basis shall sign an agreement of confidentiality containing a clause on Ethics and Integrity.

3. A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contract. There will be no annual increment/percentage increase during the contract period.

Further, an appropriate and fixed amount as Transport Allowance for the purpose of commuting between residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment.

4. Paid Leave of absence may be allowed at the rate of 1.5 days for each completed month of service to the retired Officer / Official hired on short term contract basis. Accumulation of leave beyond a calendar year may not be allowed. However, absence during curfew, bandh, strike, lockdown shall be dealt with in a similar way as in the case of serving officials.
