Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges for the year 2024-2025.

The Govt. of West Bengal, Department of Higher Education, Budget Branch in their Memo No. 20-HED-13014(99)/3/2025-BDG SEC dated 25/03/2025 have sanctioned payment of ex-gratia grant of Rs.3,500/- (Rupees Three Thousand Five Hundred only) in lump per head to all teaching/non-teaching pensioners / family pensioners of State Aided Colleges including the holders of provisional pension who retired prior to 30.09.2024 and also the pensioners who retired or died after 30.09.2024 but prior to 01.09.2025 and are not eligible to receive ad-hoc

bonus.

2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with dearness relief as on 31st March 2025 did not exceed Rs.38,000/-(Rupees Thirty Eight Thousand) only. The benefit is not admissible to those who are entitled to ad-hoc bonus sanctioned by the Government and those who are employed / re-employed under any Public Undertaking / Statutory Bodies / Non-Government Educational Institutions and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.

3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.3500/-

(Rupees Three Thousand Five Hundred) only in lump per head.

4. The payment of ex-gratia as sanctioned in the Memo should be made to the Muslim Pensioners/family pensioners immediately on receipt of this circular and other than Muslim Pensioners/Family pensioners, the payment in this regard may be made in between 15.09.2025 to 19.09.2025.
