SAS Examination-

Only existing departmental candidates are allowed to appear in SAS Exam-I of 2025.

केवल मौजूदा विभागीय उम्मीदवारों को ही 2025 की एसएस परीक्षा-I में उपस्थित होने की अनुमति है।

Incentive Examination

Divisional Accounts Officer-Grade-I who have put in one-year continuous service in the grade as on 01.03.2025 and all Sr DAOs who did not appear in this examination or could not clear the said examination while working as DAO-I are also eligible to appear /reappear in this examination.

वे मंडल लेखा अधिकारी-ग्रेड-I जिन्होंने 01.03.2025 तक इस ग्रेड में एक वर्ष की निरंतर सेवा की है तथा वे सभी वरिष्ठ जिला लेखा अधिकारी जो इस परीक्षा में शामिल नहीं हुए थे या जिला लेखा अधिकारी-I के रूप में कार्य करते हुए उक्त परीक्षा उत्तीर्ण नहीं कर सके थे, वे भी इस परीक्षा में शामिल होने/पुनः शामिल होने के पात्र हैं।

CPD-I

All Sr. DAOs are eligible to appear in the CPD-I Examination -1 of 2025, DAO-I would be eligible to appear in the examination only after completion of four years of continuous service as on 01.03.2025.

वे सभी उम्मीदवार जिन्होंने सीपीडी-I परीक्षा उत्तीर्ण करने के बाद 01.03.2025 तक 4 वर्ष की नियमित सेवा सफलतापूर्वक पूरी कर ली है, वे 2025 की सीपीडी-II परीक्षा 1 के लिए पात्र हैं।

CPD-II

All those candidates who have successfully completed 4 years of regular service as on 01.03.2025 after passing the CPD-I Examination are eligible for CPD-II Exam 1 of 2025.

वे सभी उम्मीदवार जिन्होंने सीपीडी-I परीक्षा उत्तीर्ण करने के बाद 01.03.2025 तक 4 वर्ष की नियमित सेवा सफलतापूर्वक पूरी कर ली है, वे 2025 की सीपीडी-II परीक्षा 1 के लिए पात्र हैं।

CPD-III

All those candidates who have successfully completed 3 years of regular service as on 01.03.2025 after passing the CPD-II Examination are eligible for CPD-III Exam 1 of 2025.

वे सभी उम्मीदवार जिन्होंने सीपीडी-II परीक्षा उत्तीर्ण करने के बाद 01.03.2025 तक 3 वर्ष की नियमित सेवा सफलतापूर्वक पूरी कर ली है, वे 2025 की सीपीडी-III परीक्षा 1 के लिए पात्र हैं।

Such of the eligible candidates who intend to appear in the SAS/I/CPD-I, II & III Examination 1 of 2025 may submit their duly filled in applications in the prescribed proforma (enclosed) and mail the same to wm1ahm.guj.ae@cag.gov.in by 22.04.2025. No application will be accepted after due date
