

Subject : General transfer of Divisional Accounts Officers and Divisional Accountants for the year 2025.

Your case may come up for transfer during the process of general transfer of Divisional Accounts Officers and Divisional Accountants for the year 2025.

वर्ष 2025 के लिए संभागीय लेखा अधिकारियों एवं संभागीय लेखाकारों के सामान्य स्थानांतरण की प्रक्रिया के दौरान आपका मामला स्थानांतरण के लिए आ सकता है।

2. You are advised to indicate your request, if any for the posting by location (not by divisions) out of the list of places likely to be vacant shown in the enclosed Annexure 'A'. Your request may be made in Annexure Performa (Annexure 'B') indicating also the special circumstance if any, for your request. It may please be noted that request for preference of place does not entitle you to any particular posting which will be decided by following proper procedure and on administrative consideration. Please note that your previous posting in any particular region/place will also be a factor in determining your new place of posting. Hence, while indicating your preference in Annexure B it should be kept in your notice about your earlier posting.

3. It may be noted that the seniority of Divisional Accountants due for transfer is as per Inter-se Seniority of Divisional Accountants in accordance with headquarters instructions in the matter. This is subject to final approval by Headquarters office.



4. Classification of divisions has been made on the basis of new guidelines in respect of Transfers and postings of Divisional Accounts Officers/Divisional Accountants issued by Headquarters office vide letter dated 22.01.2025. Thus Sr.DAO are entitled for Very Heavy divisions, DAO-I are entitled for Heavy divisions, DAO-II for Medium divisions and Divisional Accountants for Light divisions. Your preference of station may be made strictly according to your entitlement of divisions.

4. मुख्यालय द्वारा दिनांक 22.01.2025 के पत्र द्वारा जारी मंडल लेखा अधिकारियों/मंडल लेखाकारों के स्थानान्तरण एवं पदस्थापना के संबंध में नवीन दिशा-निर्देशों के आधार पर संभागों का वर्गीकरण किया गया है। इस प्रकार वरिष्ठ डीएओ बहुत भारी डिवीजनों के हकदार हैं, डीएओ-1 भारी डिवीजनों के लिए, डीएओ-द्वितीय मध्यम डिवीजनों के लिए और डिवीजनल एकाउंटेंट लाइट डिवीजनों के लिए हकदार हैं। स्टेशन के लिए आपकी वरीयता पूरी तरह से आपके डिवीजनों की पात्रता के अनुसार बनाई जा सकती है।

Your request (Annexure 'B') shall be accepted only by e-mail on the office e-mail ID ag-ahmd-guj@cag.nic.in with a copy endorsed to official e-mail ID of the Group Officer in-charge of the works account by 02.05.2025 meena.gopal@cag.gov.in All the officials shall mandatorily send their request through their official mail IDs only for communication. In case, multiple requests (Annexure 'B') are received from any official, the latest one only will be considered as valid.
