C I R C U L A R

The Headquarters Office vide letter No. 150/14-Exam/SAS etc Exam/2025 dated 15-04-2025 has intimated that the SAS Examination-1 of 2025 is scheduled to be held from **20-05-2025 to 26-05-2025**. In pursuance of Headquarters vide Circular No.6/NGE/2010 issued under letter No.327/NGE(APP)/09-2009/VOL.I dated 25-03-2010, a preparatory training will be held from 28-04-2025 to 19-05-2025 for SAS candidates appearing for Examination-1 of 2025. The contents of the said training would be need based aimed at facilitating the candidates in their preparation for the examination and subject to the following terms and conditions:

1. Each candidate would be allowed to avail two such spells of 15 working days Preparatory Training in his/her career.
2. No official work/duties would be entrusted to these candidates during the Preparatory Training.
3. The candidates would not be allowed to leave their Headquarters during the Preparatory Training.

The candidates of ensuing SAS examination of Examination-1 of 2025 who are desirous of availing preparatory training facility and fulfil the above-mentioned terms and conditions are required to apply through their respective Branch Officers to Branch Officer of Training Section. The candidates are required to sign the attendance register in Training Section in the morning and evening during the period of preparatory training. The period of preparatory training for the ensuing SAS Examination, if availed, will be treated as one spell.
