The meeting of the Official Language Implementation Committee (OLIC) was held under the chairmanship of Shri Raj Kumar, Principal Accountant General (Audit-I). The following points were discussed in the meeting:

Sr. No.	Item
1.	The Meeting of Official Language Implementation Committee (OLIC) was held on 25.04.2025 for the fourth quarter of the year 2024-25. During the meeting, the Principal Accountant General was appraised of the data on correspondence done with 'A', 'B' and 'C' regions, the number of documents issued under section 3(3) of the Official Language Act, 1963 and no. of letters issued under Rule 5 of the Official Language Act, 1976. During analysis, it was found that the office has done more correspondence, than the minimum target (55%) set by the Department of Official Language for 'A', 'B' and 'C' regions. The compliance of section 3(3) and rule 5 has also been ensured. Besides, the office (C region) has also achieved more than the minimum target (30%) set in Hindi noting.
2.	The Principal Accountant General expressed his satisfaction over the achievement of targets by the office on correspondence in 'A', 'B' and 'C' regions and Hindi noting. He also directed to increase percentage of correspondence and noting writing in Hindi for ensuing quarter.
3.	The Principal Accountant General again directed all the concerned sections to ensure that all the documents issued under section 3(3) of Official Language Act, 1963 are sent to the DA&RC section for uploading the same on the office's website.
4.	The Chairman also directed all the branch officers to nominate maximum numbers of officers/staff especially the newly appointed officers/staff for the Hindi Workshop.
5.	The Chairman directed the OM section to get the file covers printed with English-Hindi words and short sentences both in English and Hindi on the inner side of files for ready reference.

The meeting concluded with a vote of thanks to the Chair.
