*Subject : Grant of dearness relief to the pensioners/family pensioners of Tripura
Government Judicial Services with effect from 01-07-2024.*

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VII/DR-Judi/66 dated 12-07-2024, this is to state that the Government of Tripura in their Memo No. F.5(6)-FIN(G)/79(Part-III)/964 dated 29-11-2024 has enhanced the dearness relief from the existing rate of 50% to 53% with effect from 01-07-2024 to the pensioners/family pensioners of their Judicial Services.

Having been authorised by the Accountant General (A&E), Tripura in their authority No. Pen-1/Tripura Relief/Judicial/2023-2024/20902-951 dated 21-04-2025, it is requested to make necessary arrangement for payment of dearness relief @ 53% to all eligible pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-07-2024 after proper adjustment.
