Subject: Non-submission of electricity and water deposit receipt by the allottee of Audit pool colony to the EMS within prescribed 30 days from the date of possession of the quarter-Regarding.

Sir,

Attention is invited towards Rule 16(4)(i) of Allotment of Govt. Residences (IA&AD) Rules, 2021 vide which ***all the allottees of the govt accommodations are required to pay the charges and fees of all utility services including electricity and water etc. regularly on receipt of bill for such payment. In case of non-payment of all such dues before the vacation or surrender of the govt. accommodation, vacation or surrender of accommodation shall not be accepted.***

Accordingly, a clause has been specified in the allotment letter that ***"it is mandatory for all the allottees to submit the receipts of deposits of the Water and Electricity connection within 30 days from the date of taking possession of the quarters to Estate Management Section of this office"***. However, the competent authority has expressed concern over the non-compliance of this clause

by the majority of residents in Audit Pool Colony.

It is, therefore, requested that all the officers/officials of your office who are allottees of Type-I to VI accommodation in Audit Pool Colony, Sector 24, 41 and 42 may be informed to ensure the submission of copy of deposit receipts of electricity and water connection within 30 days from the date of taking possession of the allotted accommodation to Estate Management Section of this office. Further, officers/officials of your office who are currently residing in the Audit Pool Colony, Sector 24, 41 and 42 may be informed to submit a copy of deposits of the water and electricity connection, if not submitted earlier.
