Subject: Grant of Dearness Relief to the Jammu & Kashmir Government pensioners/family pensioners with effect from 01-07-2024.

In continuation to this office circular No. Pen. Co-ordn./Jammu & Kashmir/Vol.-III/DR/80 dated 02-08-2024, this is to state that Government of Jammu & Kashmir in their Order No. 29-F of 2025 dated 27-01-2025 has sanctioned dearness relief to JK UT pensioners/family pensioners as under:

Date of effect
Rate of dearness relief per month
01-07-2024
53% of basic pension/family pension

- 2. Payment of dearness relief involving a fraction of 50 paisa and above shall be rounded to the next rupee and the fractions of less than 50 paisa shall be ignored.
- 3. The other provisions governing grant of dearness relief on pension/family pension such as regulation of Dearness Allowance during employment/re-employment, where more than one pension is drawn etc. and other provisions of the existing orders/rules (as are not in conflict of the provisions of this order) shall continue to remain in force.
- 4. Having been authorised by the Principal Accountant General (A&E) Jammu & Kashmir in their authority No. Pen.A/c/2024-25/DA/1375-1407 dated 07-03-2025, it is requested to make necessary arrangement for payment of dearness relief @ 53% on basic pension/family pension with effect from 01-07-2024 to all eligible Jammu & Kashmir UT pensioners/family pensioners keeping in view the instructions laid down above and after making proper adjustment.
