Subject: Grant of Dearness Relief to the Goa Government pensioners/family pensioners with effect from 01-01-2025.

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR/136 dated 19-12-2024, this is to state that the Government of Goa in their Order No. 12/3/82-Fin(R&C)/Vol.II/28153 dated 06-05-2025 has sanctioned dearness relief to their pensioners/family pensioners including Ex-gratia pensioners drawing pensions under C/B/D & E series, Pensao de Sangue pensioners, pensioners receiving pension under triple benefit scheme, recipients of Ex-gratia i.e. families of deceased pensioners who were governed under EFU, pensioners sanctioned pension under Education Act 15 of 1985 and drawing pension under pension payment series T and E.B., at the rate and from the date as under:

Date of effect Rate of Dearness relief per month
01-01-2025 55% of revised basic pension/family pension

- 2) This relief is not admissible to the Freedom Fighter of Government of Goa, pensioners drawing pension which is granted after Independence for Political consideration (Ex-Rulers), MLA pensioners and Retired High Court and Supreme Court Judges for whom order will be issued separately by administrative authorities concerned.
- 3) Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4) Having been authorised by the Director of Accounts, Goa in their letter No. DA/PA-I/Pens/25-26/TR-125/DR-184 dated 16-05-2025, it is requested to make necessary arrangement for payment of dearness relief to all eligible Goa Government pensioners/family pensioners mentioned above @ 55% on their basic pension/family pension with effect from 01-01-2025 along with arrears after proper adjustment.
- 5) The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
