Subject : Grant of Dearness Relief to the Haryana Government pensioners/family pensioners with effect from 01-01-2025.

In continuation to this office circular Pen. Co-ordn./Haryana/Vol.- VII/DR/126 dated 02-12-2024, this is to state that the Government of Haryana Finance Department in their UO No. 4/3/2016-5FR/7993 dated 23-04-2025 has sanctioned dearness relief on revised pension/family pension of their pensioners/family pensioners as under :

| <i>Date of effect</i> | <i>Rate of dearness relief per month</i> |
|-----------------------|--|
| 01-01-2025 | 55% of basic pension/family pension |

2. The payment on account of dearness relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.

3. All other conditions for payment of dearness relief to pensioners/family pensioners on revised pension/family pension contained in FD's instructions No. 2/23/2016-1 Pension dated 03-03-2017, as circulated under No. Pen. Co-ordn./Haryana/Vol.- VII/Revision/57 dated 04-07-2017, shall be applicable.

4. Having been authorised by the Pr. Accountant General (A&E), Haryana in their authority No. Pen-1/Gen-26/DA/2025-26/69-159 dated 05-05-2025 (SSA No. 01 dated 06-05-2025), it is requested to make necessary arrangement for payment of dearness relief to all eligible Haryana Government pensioners/family pensioners @ 55% on their basic pension/family pension with effect from 01-01-2025 after proper adjustment.

5. The charges on this accounts are debit to the head "8793-I.S.S.A/cs.; Government of Haryana etc."
