In today's dynamic environment, leadership qualities play a critical role in ensuring effective delivery of organizational goals. Officers and officials of the IA&AD are frequently entrusted with responsibilities that demand sound judgment, motivating teams, conflict resolution, and the ability to adapt to change. Ethics play a crucial role in shaping and improving leadership qualities.

- 2. In order to strengthen these skills across the department, the competent authority has shortlisted an online course titled "Understanding Ethical Leadershi developed by the Indian Institute of Management (IIM) Raipur, on the iGOT platform.
- 3. The course addresses common misconceptions in ethical reasoning and explores the root causes of unethical behavior. It highlights the societal impact of corruption and emphasizes integrity in leadership. Participants learn effective strategies to prevent corruption, focusing on ethical decision-making that values means over ends. The course also introduces a framework for resolving ethical dilemmas and examines the Principal-Agent-Client relationship as a potential source of corruption.
- 4. In view of its importance, it has been decided that all officers/officials of IA&AD will complete this course mandatorily.
