***Subject : Grant of dearness relief to Arunachal Pradesh Government pensioners/
family pensioners with effect from 01-07-2025.***

In continuation to this office circular No. Pen. Co-ordn./Arunachal Pradesh/Vol.-V/DR/25 dated 26-05-2025, this is to state that the Government of Arunachal Pradesh in their Finance, Planning & Investment Department OM No. Estt-II-14/3/2022-ESTT-II-FPID/63 dated 09-10-2025 have sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2025	58% of basic pension/family pension

2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Audit & Pension, Government of Arunachal Pradesh in their letter No. DAP/PEN-II/99-2000/VOL-III/12-13 dated 13-10-2025, it is requested to make necessary arrangement for payment of dearness relief @ 58% on basic pension/family pension to all eligible Arunachal Pradesh Government pensioners/family pensioners with effect from 01-07-2025 after proper adjustment.
