Subject: Grant of dearness relief to the Manipur Government pensioners/family pensioners with effect from 01-10-2025.

In continuation to this office circular No. Pen. Co-ordn./Manipur/Vol.-V/DR/51 dated 28-07-2025, this is to state that the Government of Manipur in their Memo No. 2/1/2025-eFD dated 17-10-2025 has sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under:

| Date of effect | Rate of dearness relief per month |
|----------------|-------------------------------------|
| 01-10-2025 | 42% of basic pension/family pension |

- 2. The above dearness relief will also be admissible on the additional basic pension/additional family pension available to older pensioners/family pensioners based on their age.
- 3. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of dearness relief in respect of employed family pensioners and re-employed Manipur Government pensioners will remain unchanged.
- 5. Having been authorized by the Pr. Accountant General (A&E), Manipur in their authority No. GOE/DA/RP-2010/Auth/Part1/565 dated 31-10-2025, it is requested to make necessary arrangement for payment of dearness relief @ 42% on pension/family pension of Manipur Government pensioners/family pensioners with effect from 01-10-2025 as per instructions laid down above and after proper adjustment.
