In terms of Rule 18(1)(ii) of the CCS (Conduct) Rules, 1964, read with Department of Personnel & Training O.M. No. 11013/7/2014-Estt.(A-III) dated 05.01.2016, every Government servant holding Group 'A', 'B' and 'C' posts is required to submit an annual return to the Government giving full particulars of immovable property inherited by him/her or owned by him/her on lease, mortgage or otherwise, either in his/her own name or in the name of any member of his/her family or in the name of any other person.

All Sr. DAO / DAO-I / DAO-II / DA / DA(P) are hereby directed to submit the Immovable Property Return for the year 2025 (01.01.2025 to 31.12.2025) in the prescribed format, latest by 31.01.2026.

Full details of immovable property must be furnished. Expressions such as "No change" or "Same as last year" shall not be accepted. In case an officer does not own any immovable property, the same should be clearly stated in the return instead of leaving it blank. The return should be duly signed by the officer with date.

As per DoPT O.M. No. 11012/11/2007-Estt. (A) dated 27.09.2011, officers who fail to submit the Immovable Property Return within the prescribed time limit shall be denied vigilance clearance and shall not be considered for empanelment, promotion to senior level posts, or deputation, etc.

Non-submission of the Immovable Property Return within the prescribed timeline shall be treated as a violation of the CCS (Conduct) Rules, 1964, and disciplinary action shall be initiated against the defaulting official under the provisions of the CCS (CCA) Rules, 1965.
