The promotion is subject to the final decision of Hon'ble CAT/High Court/Supreme Court in the cases, if any, subjudice in Tribunal/Courts and without prejudice to the claims of their seniors.

In terms of para 5 of DOPT O.M. No. 36012/11/2016-Estt.(Res-I) (Pt-II) dated 15.06.2018, the promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court.

The promotion of the officials is further subject to the conditions laid down in DOP&T OM No. 22011/4/91-Estt. (A) Dated 14.09.1992.
