**Circular**

Reference is invited to Headquarters Circular No. 297-Staff (Appt.)/137-2019 dated 25.02.2019, wherein instructions were issued regarding regulation of inter-se seniority of Divisional Accountants in accordance with the provisions of MSO (Admn.) Vol-I. In compliance with the said instructions, this office had issued the inter-se seniority lists of Divisional Accountants vide Order No. 07 dated 21.04.2023 and Order No. 154 dated 21.02.2024.

Subsequently, a combined seniority list of the Divisional Accountant cadre of Madhya Pradesh and Chhattisgarh, prepared as per the provisions of para 10.2.1 of MSO (Admn.) Vol-I for the period from 1992 to 2007 (i.e. up to the date of bifurcation), was received from the Office of the Principal Accountant General (A&E)-I, Madhya Pradesh, Bhopal vide their letter No. WM/D-2215 dated 20.02.2024.

Further, Headquarters, vide letter No. 275-Staff (Appt.)-III/175-2023 dated 01.02.2024, provided guidance in this regard. Accordingly, based on the combined seniority list furnished by the Office of the Principal Accountant General (A&E)-I, Madhya Pradesh, Bhopal and in compliance with the instructions issued by Headquarters, this office has updated the inter-se seniority list of the Divisional Accountant cadre of Chhattisgarh.

The updated inter-se seniority lists of Divisional Accountants is enclosed herewith for information of all concerned. The officials of the Divisional Accountant cadre are hereby directed to carefully examine the lists and submit their individual representations, if any, along with reasons, to this office within **seven (7) days** from the date of issue of this Circular through Speed Post/By hand/E-mail (agacchhattisgarh@cag.gov.in). In case no representation is received within the stipulated period, it will be presumed that the concerned official agrees with the inter-se seniority as indicated in the list, and no claim in this regard will be entertained at a later stage.
