Applications are hereby invited for appointment to the following posts on deputation basis in this office on the terms and conditions and instructions issued by DoPT and amended from time to time. Further, the deputation will be regulated in terms of Hqrs Office Circular No. 60- Staff (App)-1/14-2023 dated 27-01-2025 and No. 111-Staff (App)-I/14-2023 dated 14-02-2025.

2. The eligibility criteria for appointment to the said post are as under:

Sl. No.	Name of Post	Eligibility
1	Assistant Accounts Officer	Officers under the Cadre Controlling Authority in the Indian Audit and Accounts Department holding analogous posts of Assistant Accounts Officer or Assistant Audit Officer in Pay Band-2, Pay Scale of ₹ 9300- 34800 with Grade Pay of ₹ 4800/- (along with officers who have been granted NFU).  Preference will be given to officers having knowledge of Accounts.
2	Accountant	Applicants should be holding analogous post on regular basis in the parent office in the Indian Audit and Accounts Department.

3. The period of deputation shall initially be for one year, further extendable on

yearly basis, subject to satisfactory performance of the Officials and availability of vacancy as per rule.

4. The Maximum age limit for appointment by deputation shall not be exceeding 56 (fifty-six) years as on the closing date of receipt of applications.

5. In this regard, it is requested to kindly recommend the names of eligible officers/officials who are willing and can be spared immediately in the event of their selection to the respective posts on deputation basis. The recommendations accompanied with the bio-data, certified copies of APARs for the last five years and vigilance certificate may kindly be forwarded to this office latest by 25<sup>th</sup> March 2026.
