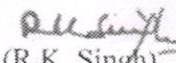

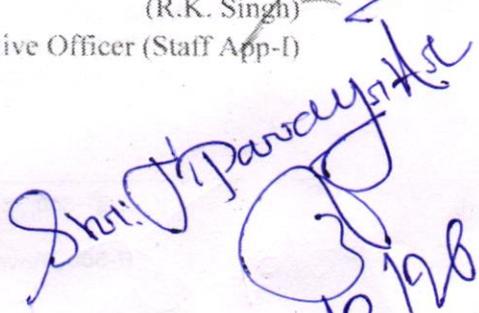

Comptroller and Auditor General (N)-I latest by 27.03.2026. Applications received after 27.03.2026 will not be considered under any circumstance.
3. In case of selection, the candidate will not be allowed to withdraw the application. In case of withdrawal of willingness after selection, the candidate will be debarred from applying to the deputation for 03 years from the date of communication of the selection by the borrowing department.

Subject: Request for deputation of officers from IA&AD to PFRDA -reg

Sir,

Pursuant to the enactment of the Pension Fund Regulatory and Development Authority Act 2013, the Government of India established the Pension Fund Regulatory and Development Authority (PFRDA) vide notification dated 01/02/2014. PFRDA is entrusted inter-alia with regulation of NPS, subscribed to by employees of Government of India, State Government. It also regulates pension products subscribed to by employees of private institutions/organisations and unorganized sectors.

2. The PFRDA's activities have expanded on multiple fronts since its establishment, further, number of subscribers and Assets Under Management (AUM) is also growing at rapid pace under the National Pension System (NPS). A lot of activities involve active and sustained collaboration with various stakeholders and intermediaries and supporting staff commensurate with the experience of handling audit related activities is required. Hence, it has been proposed that it will be useful to engage a middle level functionary familiar with the relevant experience in PFRDA.

3. In view of the above, PFRDA requires the services of two (02) officers from the IA&AD for appointment in PFRDA on deputation basis.

It is proposed that the following officers may be deputed to PFRDA:

- (i) One officer at the level of PPS/ PS and
- (ii) One Senior Audit Officer with a commercial background.

4. The officers should preferably possess knowledge and experience in liaison and protocol coordination with different Ministries/Departments, or knowledge of the financial sector including risk-return frameworks. The PPS/PS should also be well versed in noting, drafting, and preparation of minutes of high-level meetings. The number of years of remaining service should not be greater than five years.

5. The officers will be taken on deputation to PFRDA or at the NPS Trust (PFRDA is the settler of the Trust) with a possibility of absorption, in case the officer is willing and found suitable. The above staff will be appointed as Secretarial Staff (Grade 'A/B') for an initial period of up to three (03) years.

6. The terms and conditions of deputation will be on the usual foreign service terms with the option of availing the employee benefits of either borrowing or lending organization.

7. It is requested that the APARs of the candidates for the last five years along with vigilance clearance and integrity certificate may kindly be furnished to PFRDA for further consideration.
