Subject: Revision of pension/family pension in respect of pre-01-01-2016 pensioners/family pensioners of Government/Aided schools and colleges/universities/UGC/AICTE etc. as per 6th PPC, UGC, AICTE revised pay scales with effect from 01-01-2016.

This is to state that the Government of Punjab FD circular letter No. 3/1/2021-3FPPC/276 dated 29-10-2021, circulated under this office No. Pen. Co-ordn./Punjab/Vol.-VII/Revision/35 dated 25-05-2022, is also applicable to the pensioners/family pensioners of Government/Aided schools and colleges/universities/UGC/AICTE etc. as per 6th Punjab Pay Commission, with effect from 01-01-2016.

2. Arrear of revised pension/family pension with effect from 01-01-2016 to 30-06-2021 will be paid as per Government of Punjab FD circular letter No. 03/01/2021-1FP1/12 dated 18-02-2025, circulated under this office No. Pen. Co-ordn./Punjab/Vol.- VII/Arrear/21 dated 19-05-2025, as under :

- a) Immediately to the pensioners/family pensioners having 85 years of age and above as well as in case of deceased family pensioners, to their legal heirs.
- b) In 12 (twelve) equal monthly installments during the financial year 2025-26 (April 2025 to March 2026) to the pensioners having 75 years but below 85 years of age and also in case of deceased pensioners, to the family pensioner/legal heirs.
- c) In 42 (forty two) monthly installments to the pensioners below the age of 75 years, as mentioned below –

Sl. No.	Year to which the arrears relates	No. of equal monthly installments	Period for payment
1.	2016 and 2017	15	Installment will start from the month of April 2025
2.	2018 and 2019	18	Installment will start from the month of July 2026
3.	2020 and 2021 (upto 30-06-2021)	9	Installment will start from the month of January 2028

3. Arrear of revised pension/family pension to the pensioners/family pensioners of Govt. aided schools and colleges/universities etc. from 01-07-2021 to 30-06-2024, if any, will be paid as per point (b) of Government of Punjab circular letter No. FD-FE-201(SE)/5/2025-3FE2/I/1071953 dated 07-04-2025, i.e. arrear for the period from 01-07-2021 until the revised pension is paid in cash, will be paid in eight equal quarterly installments. The first four installments will be paid in the financial year 2026-27 and the next four installments will be paid in the financial year 2027-2028 as under :

2.	2027-28	4	5) 1 st Installment–June, 2027 6) 2 nd Installment–September, 2027 7) 3 rd Installment–December, 2027 8) 4 th Installment–March, 2028

4. Having been authorized by the Accountant General (A&E), Punjab in their authority Nos. Pen-12/Imp. Order/25-26/27463-497 dated 28-04-2025, Pen-12/Punjab/2025-26/31512 dated 20-06-2025 and Pension-12/Circular/West-Bengal/25-26/37592 dated 13-10-2025, it is requested to make necessary arrangement for payment of revised pension/family pension and arrears to the pre-01-01-2016 Punjab Government pensioners/family pensioners of Government/Aided schools and colleges/universities/UGC/AICTE etc. as per 6th Punjab Pay Commission, with effect from 01-01-2016 as per instructions laid down above after proper adjustment.
