Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. TRAI has been established to regulate Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to fill up **the post of Joint Advisor in TRAI HQ, New Delhi on deputation on foreign service terms, initially for a period of three years.** The required qualification and experience for the said post is given below: -

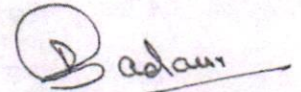

3. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June 2010, as amended from time to time. **The maximum age for appointments on deputation shall in no case exceed 56 years on the last date of submission of applications in TRAI.**

4. The applicants fulfilling the eligibility criteria and having relevant experience, etc., may apply through **online mode only** on URL: <https://vacancies.trai.gov.in>. Further, if an officer joins TRAI and later seeks to return to their parent organization before completing the deputation tenure, he/she will be barred from applying for future TRAI vacancies for a period of three years.
