*Subject : Grant of Temporary Increase (dearness relief) to the
Gujarat Government pensioners/family pensioners
with effect from 01-01-2026.*

In continuation to this office circular No. Pen.Co-ordn./Gujarat/Vol.-VI/DR/110 dated 15-12-2025, this is to state that the Government of Gujarat in their FD Resolution No. HGV-102017-O-450-Pension cell (P) dated 19-05-2026 has sanctioned Temporary Increase (dearness relief) on revised pension/family pension of their pensioners/family pensioners as under:

<i>Date of effect</i>	<i>Rate of Temporary Increase per month</i>
01-01-2026	60% of basic pension/family pension

2. Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.

3. Payment of Temporary Increase involving a fraction of a rupee shall be rounded off to the nearest (lower or higher) rupee.

4. Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.

5. Having been authorised by the Accountant General (A&E), Gujarat in their authority No. Pension/Accounts & Entitlement/G.R./Special Seal/Gujarat/2026-27/O.W. No. 144 dated 22-05-2026, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their revised basic pension/family pension @ 60% with effect from 01-01-2026 after proper adjustment.

6. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Gujarat etc."
