*Subject : Grant of dearness relief to Arunachal Pradesh Government pensioners/
family pensioners with effect from 01-01-2026.*

In continuation to this office circular No. Pen. Co-ordn./Arunachal Pradesh/Vol.-V/DR/96 dated 19-11-2025, this is to state that the Government of Arunachal Pradesh in their Finance, Planning & Investment Department OM No. Estt-II-14/3/2022-ESTT-II-FPID/201 dated 06-05-2026 have sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under :

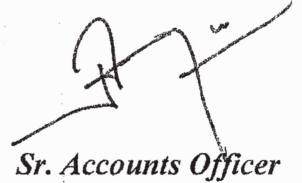
Date of effect	Rate of dearness relief per month
01-01-2026	60% of basic pension/family pension

2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Audit & Pension, Government of Arunachal Pradesh in their letter No. DAP/PEN-II/99-2000/VOL-III/14-15 dated 11-05-2026, it is requested to make necessary arrangement for payment of dearness relief @ 60% on basic pension/family pension to all eligible Arunachal Pradesh Government pensioners/family pensioners with effect from 01-01-2026 after proper adjustment.
