*Subject : Grant of dearness relief to the Goa
Government Freedom Fighter pensioners/family
pensioners with effect from 01-01-2026.*

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-VI/DR-FF/141 dated 17-02-2026, this is to state that the Government of Goa in their Department of Home (General) Order No. 12/3/82-Fin(R&C)/Vol.II/31928 dated 29-05-2026 has adopted the rate of dearness relief announced by the Central Government in respect of their Freedom Fighter pensioners/family pensioners, raising it from 58% to 60% with effect from 01-01-2026.

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/25-26/TR-216/DR-292 dated 10-06-2026, it is requested to make necessary arrangement for payment of dearness relief on pension/family pension to the Goa Government Freedom Fighter pensioners/family pensioners @ 60% with effect from 01-01-2026 after proper adjustment.

4. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
