Applications are invited from eligible officials for appointment to the posts of **Accountant and Senior Accountant on deputation basis** in the Office of the Accountant General (A&E), Karnataka, Bengaluru.

Sl. No.	Name of the Post	Level in Pay Matrix	Eligibility
1.	Senior Accountant	Level-6	Officials holding analogous posts of Senior Accountant in Level-6 of the Pay Matrix in the Indian Audit and Accounts Department, or officials otherwise eligible for appointment to the post as per the Recruitment Rules in force, may apply.
2.	Accountant	Level-5	Officials holding analogous posts of Accountant in Level-5 of the Pay Matrix in the Indian Audit and Accounts Department, or officials otherwise eligible for appointment to the post as per the Recruitment Rules in force, may apply.

1. The deputation shall initially be for a period of **one year**, further extendable on yearly basis, subject to administrative convenience, availability of vacancy in the respective cadre and fulfilment of the conditions prescribed under the relevant rules/instructions.
2. The last date for receipt of applications shall be **within 30 days from the date of issue of this Circular**.
3. It is requested to kindly recommend the names of eligible officials who are willing and can be spared immediately in the event of their selection for the above posts on deputation basis at Office of the Accountant General (A&E), Karnataka, Bengaluru
4. The recommendations/applications should be accompanied by the following documents/certificates:
 - I. Photocopies of **complete and up-to-date APARs for the last five years**, duly attested on each page.
 - II. **Integrity Certificate**.

- III. **Vigilance Clearance Certificate**, certifying that no disciplinary/court/vigilance case is pending or contemplated against the official.
5. The deputation shall be applicable subject to **Recruitment Rules in force and deputation guidelines issued on 27.01.2025.**
 6. The maximum age limit for appointment by deputation shall be **not exceeding 56 years as on the closing date for receipt of applications.**
 7. **Deputation allowance** shall be admissible as per the relevant instructions of DoPT, as amended from time to time.
 8. The deputation shall be subject to compliance with the **Headquarters instructions/policy on deputation circulated vide letter dated 27.01.2025** and other instructions issued from time to time.
