

**ANNUAL REVIEW REPORT ON THE WORKING OF THE TREASURIES IN
ODISHA FOR THE YEAR 2013-2014**

PART-I

Introductory :

1.1 In the State of Odisha all financial transactions and accounting are carried out through Treasuries / Spl Treasuries / Sub-Treasuries.

On behalf of Govt. of Odisha, all moneys are collected, disbursed and accounted for through the Treasuries. The paramount responsibility for proper and effective functioning of the system are bestowed upon the Treasuries. Any failure on part of the Treasuries would undermine the fiscal management of the State. With a view to ensuring proper working of the Treasuries, the Pr. Accountant General (A&E), Odisha conducts regular inspection of the Treasuries every year and brings out an Annual Report summarizing the results of such inspection. The Annual Report on the working of the Treasuries for the year 2013-2014 has been prepared incorporating brief analysis of the deficiencies and irregularities noticed during compilation of accounts in the Office of the Pr. Accountant General (A&E), Odisha and those noticed during inspection of the Treasuries.

Some of the deficiencies and irregularities though reflected in the earlier Reports too, have not yielded tangible results, exhibiting lack of concern regarding healthy financial management by the Treasuries.

1.2. Organizational set up : -

In Odisha, there are 30 District Treasuries, 9 Special Treasuries and 127 Sub-Treasuries, a list of which is given in **Annexure -‘A’**. These Treasuries are administratively controlled and supervised by the Director of Treasuries and Inspection, Odisha, Bhubaneswar.

In order to improve quality in accounts and to cope with the present day computerized environment, all the Treasuries in State of Odisha have been computerized. The computerized Treasury System is controlled by the Odisha Treasury Management System at Bhubaneswar. One CYBER Treasury has started functioning with effect from 24.02.2010 at Bhubaneswar having the status of a Special Treasury to collect receipts of the State Government electronically.

1.3. Disposition of Treasury staff: -

The position of Treasury personnel as received from the Director of Treasuries and Inspection, Odisha for the last 5 successive years is as under.

It is imperative to have adequate trained manpower for correct and complete accounting of transactions.

PART –II

2.1 Increase in Suspense Balance: -

In the course of compilation of Treasury accounts, it was noticed that in a number of cases, the paid vouchers were not submitted along with payment schedules which resulted in accumulation of Objection Book Suspense of this office. The accounts, thus, fail to present a true and fair view of the accounts of the State and fraudulent drawals, if any, from the Treasuries remain undetected. A Statement of such wanting paid vouchers for the year 2013-2014 is shown in **Annexure-‘B’**.

It was found that out of total OB Suspense of Rs.7,45,35,722 during 2013-2014 ,OB Suspense of Rs. 6,63,02,003 relates to 7 District Treasuries which failed to submit paid vouchers along with payment schedules resulting in huge accumulation of OB Suspense as detailed below.

In this connection provisions of SR-31 to 34 of OTC have to be followed which lay down the procedure regarding submission of Accounts. Intentional / deliberate delay in submission of vouchers with list of payments should be discouraged.

2.1.1 List of Vouchers having arithmetic inaccuracy.

The Treasuries are required to check the correctness of arithmetical calculation of the bills before those are passed for payment as per provisions of Odisha Treasury Code. But it was noticed that the Treasuries failed to exercise such routine checks in the cases illustrated in **Annexure-C**, as a result of which the discrepancies had to be kept under suspense, pending receipt of clarification from the Treasury Officers / Drawing and Disbursing Officers concerned.

It was seen that in case of Angul District Treasury there was a difference of Rs.6,31,000/- during the month Oct'2013 between SOP amount and voucher due to failure of the Treasury Officer in exercising proper check of correctness of arithmetical calculation of the Bill, before they are passed for payment which resulted in increase of OB Suspense.

2.2 A.C Bills outstanding for settlement: -

Provisions of SR-260 and 261 of OTC Vol-I read with Rule-84 of OGFR vividly describe the procedure for drawals through A.C bills and submission of D.C bills there of which inter alia states that Detailed contingent bills for the A.C bills drawn before the previous month should be submitted by the D.D.Os to their Controlling Officers for countersignature and onward submission to the A.G (A&E) failing which further drawal of funds through A.C bills shall not be permitted and the Treasuries should, therefore, be strict in observance of these instructions.

It was however noticed that as many as 4903 nos. of A.C Bills amounting to 114.48 crore are pending for adjustment till March 2014, shown in **Annexure –“D”**.

The following Dist. Treasuries, for example, have huge amount pending for adjustment.

2.3 Wrong inclusion of transactions under GPF (State) : -

Receipt and payment relating to other major heads/minor heads of accounts were found misclassified by the Treasuries under the head of A/c “8009- GPF”-101-GPF (State) in spite of proper classification given on the body of the Chalans/ vouchers by the Drawing and Disbursing Officers. This causes difficulties and delay in accounting of such transactions under respective Head of Accounts. The debits pertaining to AEIPF (TPF) were mostly

misclassified by the Treasuries under 8009-GPF (State). In spite of repeated mention in the Review Reports the position has not improved and misclassification of AEIPF (TPF) continues. An amount of Rs.48, 79,468/- pertaining to AEIPF (TPF) during 2013-2014 had been booked under 8009-State P.F.

The following District Treasuries, for example, are having maximum wrong inclusion of transactions under GPF (State).

2.4 Outstanding pension claims from CPAO New Delhi :-

Pension payments to the central civil pensioners and central political pensioners are made by the Treasuries in the first instance and the expenditure to that effect is subsequently reimbursed by the CPAO, New Delhi. The treasuries initially book the expenditure under “8658- suspense Account 101- PAO suspense” adjustable by the CPAO, New Delhi and the AG.(A&E), Odisha arranges to prefer the claims to the CPAO, for such amounts as booked by the Treasuries under suspense. For the purpose of settling the claims at the level of the CPAO, New Delhi, the Treasuries are required to transmit the pension vouchers to the CPAO directly.

However, during review, it is observed that an amount of Rs.7,18,18,692 remained un-recouped for central pension vouchers submitted to CPAO, New Delhi during the year 2013-2014.

Similarly the amount pending with Railways and Defence are Rs.78,57,318/- and Rs.2,02,44,982/- respectively during the year 2013-2014. The quantum of pension vouchers remained un-recouped is shown in **Annexure –‘F’**.

2.5 Non- submission of schedules/ Challans in support of GPF / HBA /MCA recoveries:

As per Codal provisions, all schedules/ Chalans in support of provident Fund / HBA/ MCA recoveries must accompany the salary voucher / receipt schedule in order to facilitate the posting of the amounts in the respective subscriber’s/ loanee’s account. It was, however, noticed that in many cases, in the absence of relevant schedules/ Chalans, the amount could not be accounted for in the accounts of the respective subscribers/ loanees.

It was seen that almost all the Treasuries had failed to furnish relevant schedules/Challan in almost all the accounting months which leads to accumulation of huge amount of missing credits to the tune of Rs.43,37,557/- involving 204 Challans in respect of Provident Fund/HBA /MCA.

The following is an illustrative picture of non- submission of schedules/ Challans in support of GPF / HBA /MCA recoveries by some treasuries.

2.6 Delay in rendition of Accounts.

A review of the position of submission of monthly accounts by the Treasuries during the year 2013-2014 revealed that despite several instructions, late submission of accounts

continued to prevail in the Treasuries during 2013-2014 also. Average delay ranged from 1 to 14 days in respect of 1st and 2nd list of accounts.

It was seen that there is persistent delay in submission of first list of Accounts by all the Treasuries. In case of Dist –Try Bargarh and Sambalpur, there was delay in submission both in respect of first and second list of Accounts which ranged between 1 to 26 days. The following is an illustrative picture of delay in rendition of Accounts by some Treasuries.

The Treasury wise list indicating such delay is given in **Annexure-‘H’**. Timely submission of Accounts with reduction of operational errors may be ensured by the Treasuries for achieving a qualitative account of the State.

2.7 Requisition for correction of Accounts: -

There were a large number of requisitions for correction of accounts received during the year 2013-2014 from Treasuries as shown in **Annexure-‘I’**.

It was seen that out of 38 District Treasuries a good number of Treasuries i.e. 31 Treasuries had requested for correction of accounts , instances ranged from 1 to 18 times during 2013-2014. Further, the following treasuries had requested a number of times for correction of accounts 2013-2014 which is highly irregular and should be avoided in future.

This indicates that proper care was not taken in preparation of initial accounts at the Treasury level in conformity with codal provisions.

2.8 Non- Submission of Lapsed Deposits Statements :-

At the close of March each year, the Treasury Officers are required to submit a statement of lapsed deposits in accordance with the provisions of SR- 436 of OTC Vol-I, in order to enable the Accountant General's Office to credit the lapsed amount to Govt. account by transfer entry. It was, however, noticed that statements of lapsed deposits were not submitted by the Treasury Officers as shown in **Annexure-‘J’**.

Further, it was seen that the some treasuries have not submitted lapsed deposit statements for last 20 years, which is highly irregular. Few examples are given below:-

2.9 Non- Submission of Plus & minus memoranda : -

Plus and minus memoranda in respect of Deposit Heads of Account and PL accounts are required to be furnished by the Treasury Officers along with the monthly Accounts in accordance with the provisions of SR- 476 of OTC Vol-I, read with Rule – 97 of Accounting Rules for Treasuries 1992.

But most of the Treasuries failed to furnish the Plus minus memoranda either for the entire financial year or part there of, in the absence of which it was not possible to check the correctness of the Deposit accounts and PL Accounts maintained by this office.

It was seen that some of the treasuries have not submitted plus minus memo for the entire period of 2013-14.Few examples are given below:-

The deficiency has repeatedly been reflected in the IRs but no fruitful result achieved. Few such instances are shown in **Annexure –“K”**.

2.10 Non- Submission of Annual Balance Certificates under deposit heads of account and other heads of Account : -

During review, it was noticed that 38 Treasuries failed to submit the A.B.Cs for the year 2013-2014 as on 30.06.2014 which contravenes the provisions of SR-479 of OTC. As a result, Treasury wise reconciliation of balances under the Head of Account “8443-Civil Deposit”/ “8448-Deposits of Local Funds” could not be fairly conducted.

Some treasuries who have the highest no of P.L Account Administrators under their jurisdiction have failed to submit Annual Balance Certificate. A few examples are given below:-

PART-III

Important irregularities noticed during local inspection of Treasuries

3.1 Status of Inspection of Treasuries:-

During 2013-2014, 30 district Treasuries 8 Special Treasuries and 62 Sub-Treasuries were inspected by the inspecting staff of the Pr. Accountant General (A&E). Details are placed at **Appendix-“I”**.

The irregularities and lapses noticed during 2013-2014 were brought to the notice of the Treasury Officers / Sub-Try Officers concerned through Inspection Reports issued by this office. Copies of Inspection Reports have also been sent to the Director of Treasuries and Inspection, Odisha and the District Collectors concerned.

Some of the important irregularities and lapses noticed during inspection are elaborated in subsequent paras.

3.2. Outstanding Paras : -

The position of outstanding IRs as on 31.03.2014 relating to different Treasuries / Sub-Treasuries is indicated in **Appendix-“II”**, to this report. It is seen that as many as 2227 Paras concerning to 444 Inspections Reports from the year 1976-77 onwards are outstanding awaiting final compliance from the Treasuries/ Sub-Treasuries. The negligence in submission of compliance to these IRs and the lack of follow up corrective measure to avoid recurrence of those irregularities defeats the very purpose for which the inspections were conducted. Expressing concern over the issue, the D.T.I (O) in his Circular No. TP-65/07(pt)/14429(38) dt. 02.07.07 impressed upon and directed all the Treasury Officers for timely submission of compliances to the I.Rs within one month from the date of receipt of the reports and to take up appropriate and corrective measures to settle the outstanding paras.

D.T.I, Odisha also conducted Triangular Committee Meetings for settlement of Outstanding IR s and paras during 2013-2014. Such T.C Meetings were held in respect of 20 Treasuries and 640 paras belonging to old Inspection Reports were settled.

3.3 Irregular payment of pension benefits without exercising proper checks

3.3.1 Excess payment of Pension and Gratuity:

A test check of the Treasury records relating to pension and gratuity payments revealed that excess payment of pension and other retirement benefits aggregating to Rs.12,71,316/- were made under different categories /reasons. In a number of cases it was observed that required checks by the TOs / STOs were not exercised with due care as a result of which irregular payment of pensionary benefits were made. A few such instances are given below. Immediate attention is required for regularization of the excess payments. Treasury wise list of excess payments made during 2013-2014 is enclosed at **Appendix-“III”**. Considering the magnitude of excess payments, the Treasuries are required to exercise close scrutiny while passing pension bills.

(a) Excess payment of pension due to arithmetical inaccuracy:-

Excess payment of Rs.84,888 was made to the pensioners due to wrong calculation of monthly pension /arrear pension in 33 instances relating to 21 Treasuries (Appendix –III-A).

An illustrative example is given below.

Sri Surendra Prasad Panda, Holder of PPO No. 90660, ID No. 431 was paid provisional pension + T.I by the DDO for Rs.1,53,896/- .But at the time of 1st payment of pension on 09.05.13, Rs.1,25,084/- was deducted (due to wrong totaling) resulting excess payment of Rs.28,812(Rs.1,53,896-Rs.1,25,084).

(b) Excess payment of pension due to delayed commencement of reduced pension

Excess payment of Rs.4, 36,853 was made to the pensioners due to delay in commencement of reduced pension in 73 instances relating to 40 Treasuries.(**Appendix –III-B**)

An illustrative example is given below.

It was noticed that while payment of 1st pension to Sri Harekrushna Samantaray, holder of PPO No. 508995, ID No. 1205 on 24.7.2013 the date of commencement of reduced Pension (RP) was taken as 24.7.2013 instead of 18.8.2010 as he has drawn Provisional Commuted value of Pension on 18.8.2010 .This has resulted in excess payment of Rs.72,217/- for the period from 18.08.2010 to 23.07.2013.The detailed calculation is given below:

Sri Harekrushna Samantaray, holder of PPO No. 508995 was paid excess Pension of Rs.72, 217/- for the period from 18.08.2010 to 23.07.2013 @ **Rs.2,052/-** (Commuted portion) due to delayed commencement of reduced pension.

(c) Excess payment of family pension due to payment at enhanced rate beyond stipulated date

Excess payment of Rs.78, 325/- was made to the pensioners due to payment of enhanced rate of Family Pension beyond stipulated date in 4 instances relating to 4 Treasuries (**Appendix-III-C**).

An illustrative examples is given below

Smt. Binapani Mansingh holder of PPO No. 13413 AF was paid an excess amount of Rs. 57,298/- due to payment of Family Pension at enhanced rate @ Rs.7,165/- p.m for the period from 07.11.2012 to 30.09.2013.

(d) Excess Payment of Pension due to other miscellaneous reasons :

Excess payment of Rs.6,71,250/- was made to the pensioners due to wrong adjustment of Pension/CVP and other miscellaneous reasons under 69 instances relating to 40 Treasuries (**Appendix-III-D**).

Few illustrative examples are given below.

(i) Sri Krushna Chandra Barlenda, Holder of PPO No. 91077/AEI, ID No. 4923 was paid his 1st pension for Rs.24,373/- after adjustment of provisional pension drawn for Rs.64,134/-.But the provisional gratuity of Rs.95,000/- drawn by him as per Lr. No 3,741/- dated. 27.04.13 of District Education Officer, Bolangir was not adjusted from the gratuity

and full amount of Rs.1,19,723/- was paid on 27.05.13 resulting excess payment of Rs.95000/- **(I.R No.39/2013-14 Para 1(a)(i) District Treasury ,Bolangir)**

(ii) Sri Digamber Pradhan, holder of PPO No- 406826 was paid Provisional Pension for the period from 5/2011 to 10/ 2012 amounting to Rs.2, 16,597/- .But at the time of payment of 1st pension Rs.2, 01,477/- only was adjusted resulting in excess payment of Rs.15,120/- (Rs.2, 16,597/- - Rs.2, 01,477/-).

(iii) Sri Sudarshan Khamari, PPO No. 508803-S , ID No. 1518 was paid provisional pension of Rs. 168501/- for the period from 02/12 to 01/13. But while adjusting the provision of Pension a sum of Rs. 59736/- only was deducted resulting excess payment of Rs 1,08,765/- (Rs.1,68,501/---Rs.59,736/-).

(iv) Sri John Minz holder of PPO No- 404283, was paid Provisional Pension of Rs.4,77,014/- from 08/ 2008 to 04/2012. But while adjusting Provisional Pension a sum of Rs.4,64,579/- only was deducted resulting excess payment of Rs12,435/- (Rs.4,77,014/- - Rs.4,64,579/-).

(v) CDMO, Sundargarh in his Letter No-1611 dated-27.02.2013 had suggested to recover Rs.28,560/- towards Arrear House License Fees for the period from 06/2010 to 07/2011 and Rs.737/- towards excess payment of Pay & Allowances from 1st time payment of Pension of Sri Sachindra Bukhra, holder of PPO No- 507587. But the said amount was not recovered as the Pensioner had requested to recover the same from the DCRG. Again, Provisional DCRG amounting to Rs.2, 46,905/- had already been drawn leaving no scope for adjustment of Rs.29, 297/- (Rs.28, 560/-+Rs.737/-). The arrear Pension for Rs.26, 852/- was also paid on 15.03.2013 but the said excess amount was not adjusted

(I.R No.90/2013-14, para 2(g), District Treasury ,Sundargarh)

3.3.2 Un-drawn Pension / unauthorized retention of closed PPOs : -

SR-317(ii) of OTC Vol-I provides that if a service pension remains undrawn for three years, and a political pension remains undrawn for six years it can not be paid without the authority of Accountant General.

Such pension cases which are ceased to be payable during life time of a pensioner (SR-319) should be returned to the authorizing organizations forthwith in order to prevent from those being misused.

It was however observed that several closed cases had been retained in the Treasuries un-authorisedly .Review of such closed cases was not conducted in the Treasuries regularly

on account of which the status of such closed cases could not be clearly ascertained. This contravenes the codal requirements envisaged in SR-319 of OTC.

An illustrative example of some such closed and undrawn pension cases are shown below:-

3.4 Retention of Time barred GPF authority :-

The periodicity of GPO & GPF authorities is one year and six months from the date of issue respectively. It was observed during inspection that a number of such authorities were retained by the Treasury Officers instead of returning them to the issuing offices. Few instances are cited below :-

3.5 Stamp Account: Huge retention of stamps in the Treasuries: -

During inspection of Treasuries, it was observed that huge number of stamps were retained in the Treasuries in excess of actual requirements.

Huge number of unused OET Stamps and water marked plain papers were kept in the strong room for long periods. Out of that, some category of stamps have also become unserviceable due to prolonged stacking/storage.

In this connection, although DTI (O) in his circular No. 11828 dt. 28.7.94 and No. 79/96-19558(160)/DTI dt. 28.8.97 communicated the procedure for disposal of such huge stock of OET stamps, the Treasuries failed to implement it in action.

It was noticed that a sizable quantity of stamps of different other categories were kept in the Treasuries which is in excess of the reasonable requirements of the Treasuries even in near future. No transactions have taken place in respect of those stamps for a long period.

The following treasuries have retained huge stock of stamps which indicates that there was no clear cut indent policy for requisition of stamps.

Apart from the list at **Appendix – IV**, huge quantity of damaged stamps are also kept in the strong room which are required to be disposed off/destroyed as per procedure outlined in Odisha Supply and Sale of Stamps and Stamp Paper Rules, 1990 and their value written off from the stocks after obtaining approval of the Finance Department. Effective steps from Government is required in this regard.

It was found that Dist. Treasuries like Bolangir, Khurda, Cuttack ,Bargarh, Puri, had the maximum value of unused /damaged stamps as seen below :-

To avoid the stamps, becoming unserviceable in course of time, those should be transferred to needy Treasuries immediately. Details are exhibited in **Appendix - IV**.

3.6 Irregularities in maintenance of P.L Accounts: -

As provided under Note-2 below SR-423 of OTC-I all the P.L. accounts remaining in-operative for three full financial years shall be closed automatically and the balance shall be transferred to Govt. account by means of transfer entry in the Office of the A.G.(A&E). For such purposes, the unused cheque books remaining with the Administrators should be brought back and cancelled, the agreement of balances between the Administrators and the Treasury should be agreed upon and a proposal for transferring the balances to the source head of Account should be submitted by the Treasuries to the Pr. A.G (A&E).

But, it was observed that an amount of 36.03 crore remained unspent in respect of 1954 schemes operated by 275 P.L Account Administrators coming under the jurisdiction of 99 treasuries. There is diversion of fund of Rs.4.7 crore in 25 schemes operated by 11 P.L Administrators. Further, there was an excess expenditure of 28.84 crore by 63 P.L Administrators under different schemes resulting in minus closing balances. Examples of such in-operative P.L Accounts/Schemes are exhibited in **Appendix-V**.

3.7 Retention of huge balance in P.L Accounts of Administrators:-

Scrutiny of P.L Accounts of Administrators revealed that huge balance were retained in different Administrators P.L Accounts without being utilized in the proper head for which the money was provided. Some of such examples are shown below: -

3.8 Inspection of Strong Room and Issuance of Safety Certificate : -

With a view to ensuring the safety and security of the Strong room of the Treasuries/Sub-Treasuries, where valuables of the Govt. are stored, it is provided in S.R 71(ii) of O.T.C-Vol-I and note there under that Strong room of the Treasury should be inspected annually by the P.W.D, Executive Engineer, or by his Subordinate Officer nominated for the purpose and a certificate of safety to be issued by such inspecting officer. It was, however, noticed that neither the P.W.D authorities had inspected the Strong Rooms in many cases nor any suitable initiative was taken by the Treasury/Sub Treasury Officer to get the strong rooms inspected. A few such instances are indicated in **Appendix-VI**.

3.9 Rolling of unutilized funds under 8443-Civil Deposit-800-Other Deposit : -

Balance in Civil Deposit form part of the financial liability of the State Government. Due to rolling of huge balance under 800-Other Deposit, Government of Odisha, Finance Department in their Circular No. 33337 (255) / F dated 30.07.2010 chalked out a road map for phasing out accumulated amount in the Civil Deposit. As per the circular, Civil Deposits upto the financial year 1999-2000 are allowed to lapse by 3/2011 and Civil Deposit from 2000-01 to 2004-05 should have been lapsed by 3/2012 and necessary adjustment entries made.

Contrary to the above order of the State Government it was observed that huge balance to the tune of Rs.49.96 crore has still been rolling under 800-Other Deposit for a long period and no step has been taken by the concerned authorities to reduce the balance.

3.10 Issue of CTR/CTI neglected: -

As per provision of S.R. 403 of O.T.C. Vol-I and notes there under, the Treasury Officer is required to issue a Consolidated Treasury Receipt (CTR) in respect of whole of the remittances, received during the month and a Certificate of the Total Issues (CTI) in respect of Cheques drawn by the Divisional Officers under the jurisdiction of the Treasury to the Divisional Officers of P.W. Divisions by 20th of the following month as stipulated in D.T.I.'s letter No.TE-57/83-17261(19) dated 2.8.83 and A.G's Lr.No WAC-IV-Form-51-1586 dt. 29.3.96 for onward transmission to the Accountant General together with Form 51. It was, however, noticed that CTRs/CTIs were not regularly issued by the Treasury Officers to P.W. Divisions for which discrepancies between the Treasury and Divisional Accounts remain unreconciled. Instance of a few defaulting Treasuries are given in **Appendix-VII**.

Apart from this, although it is expressly provided in the SR-410 of OTC Vol-I to issue CTRs to the Forest Division on the 1st of the ensuing month such returns are never sent although the Forest Divisions are regularly transacting their business with the Treasury in the same line and action as P.W. Divisions. This needs attention of higher authorities.

3.11 Irregular honouring of A.C Bills : -

As per provisions of SR-260 read with Rule-84 of OGFR, not more than one A.C Bill under one unit of expenditure can be drawn in a day. In cases, where no such financial stipulations are indicated, the Controlling authorities impose certain conditions in their sanction orders which should be scrupulously watched by the Treasuries while honoring the AC Bills.

Apart from the above, as per SR-261 ibid no A.C bills should be honoured for drawals unless DC bills in respect of A.C bills drawn before the previous month are submitted to the Controlling Officers by the DDOs.

However, during inspection it was observed that most of the Treasuries do not adhere to the codal restrictions scrupulously while honoring the A.C bills which is against financial decorum.

3.12 Delay in rendition of LIC Premium Schedules.

As per DTI (O) Circular No.18745 dt. 03.12.94 and No.18738 dt. 10.05.96, the schedule of LIC Premia should be remitted by 15th of the following month to LIC authorities. But it was observed that the Treasury Officer do not remit the same in time. Instances of delay were noticed in the following Treasuries.

3.13 Reconciliation of Court Deposits

In almost all the Treasuries, the balances appearing under 8443- Civil Deposit -104-Civil Court Deposit and 8443- Civil Deposit -105-Criminal Court Deposit were never verified and reconciled with the extracts of Court Registers which violates provisions under SR-444 of OTC Vol-I. This exhibits Treasury balances almost unauthentic and unrealistic.

Instances of a few such Treasuries are shown in **Appendix-VIII**.

3.14 Annual Verification of Valuables, deposited in the Treasuries: -

As provided under S.R 88(c) *ibid*, sealed packets/bags containing valuables which are lodged by different Drawing Officers in the Treasury for safe custody are required to be verified by the depositing officers in the month of April each year and the fact of such verification noted in the Register of Valuables. At the end of April, the Treasury Officer should review the position and serve notices upon the depositing officer in case the valuables are not verified by him and direct him to take back the valuables within 15 days from the date

of receipt of such notice. It was, however, observed that annual verification of sealed packets was neither conducted by the depositors in most of the cases nor any action was taken by the Treasury Officers in this regard resulting unnecessary dumping of many old deposits for years together. Instances of the Treasuries/Sub-Treasuries where most of the sealed packets stood unverified is given in **Appendix-IX**.

3.15 Improper maintenance of issue register of Book of Drawals : -

As per instructions issued in D.T.I's Circular 3376(80) dt. 14.2.75, No. 6810(80) dated 11.4.75 and No. 15127 dated 30.7.83, special care is required to be taken whenever a new Book of Drawal is introduced for an existing office or for an office newly created. For this purpose a separate letter in the form of an advice should be sought for in a sealed cover from all such DDOs in whose favour new Books of Drawals are to be issued requesting them to specify the date of first operation of the new Book of Drawal, the commencing bill number and date.

Check of relevant records in the Treasuries/Sub-Treasuries revealed that DDOs in whose favour new Book of Drawals were issued have neither furnished the above information nor they were insisted upon to comply with the deficiency. A few such instances are given in **Appendix-X**.

3.16 Improper maintenance of Bill Transit/Token Register/proper accountal of Tokens:-

Following lapses and irregularities were noticed in the maintenance of the Bill Transit/Token Register.

(i) Receipt of Bills and Cheques from various Drawing and Disbursing Officers in the Treasuries were not signed with date by the concerned bill receiving clerk of the Treasuries and entered in the Bill Transit Register.

(ii) Stock of tokens in hand at the close of the day were not verified by the Treasury Officers as required vide Note 1 and 2 below S.R 383 of O.T.C-Vol-I, as a result, the number of tokens missing could not be ascertained.

(iii) Token accounts are not being done correctly by most of the Treasuries.

A few instances of such lapses made by Treasuries are given in **Appendix-XI**.

3.17 Improper maintenance of Advice/Challan/Pension Enfacement Register: -

As per SR-386,387 of OTC Vol-I read with G.O.F.D No. 45539/TRA/441/77/F dt. 2.9.77 and No. 2391 dt.8.9.91, the debit/credit scroll No and date are required to be noted against the corresponding entries made in the Advice/Challan and Pension Enfacement registers to ascertain the correctness of payment or receipt as the case may be.

It is observed that most of the treasuries do not follow above codal provisions which may lead to system failure. A few instances are exhibited in **Appendix-XII** (In this

connection the Treasuries should follow the instructions of the DTI (O) communicated in his circular No. TP-32/96-1387(160) / DTI dt. 24.1.97 and No. Pen-II-29/81-14936(91) dt. 11.6.81 regarding proper maintenance of the above registers)

3.18 Miscellaneous Irregularities/Treasury Establishment

Excess payment of Rs.2,175.00 was made to the staff of Treasury Establishment in 3 instances relating to 3 Treasuries due to wrong fixation of pay and other miscellaneous reasons in the following cases:
